- 1. This Order may be cited as Prices Control Order No. 207.
- 2. Prices Control Order No. 158, as amended by Prices Control Order No. 188, is hereby further amended (a) by omitting from the Schedule thereto the maxi-

 - (c) by inserting at the end of the Schedule thereto the items specified in the first column of the Third Schedule to this Order, and the maximum prices for such items specified in the second, third, fourth, fifth, sixth, seventh, eighth, ninth, tenth, eleventh, twelfth, thirteenth and fourteenth columns of such lastmentioned Schedule.
