PRICES CONTROL ACT, 1948-1949.

Prices Control Order No. 278.

Retail Prices of Groceries.

IN pursuance of the powers conferred upon me by the Prices Control Regulations, 1949, I, Constantin Paul Mathea, Price Control Commissioner, hereby make the following Order:—

Citation.

- 1. This Order may be cited as Prices Control Order No. 278.
 - 2. Prices Control Order No. 258 is hereby amended-
 - (a) by omitting from the Schedule thereto the maximum prices appearing in the second, third, fourth, fifth, sixth, seventh, eighth, ninth, tenth, eleventh, twelfth, thirteenth and fourteenth columns of such Schedule opposite the items specified in the first column of the First Schedule to this Order, and inserting in their stead the maximum prices specified in relation to the said items in the second, third, fourth, fifth, sixth, seventh, eighth, ninth, tenth, eleventh, twelfth, thirteenth and fourteenth columns of the lastmentioned Schedule;
 - (b) by omitting from the Schedule thereto the items specified in the first column and the prices for such items specified in the second, third, fourth,

- fifth, sixth, seventh, eighth, ninth, tenth, eleventh, twelfth, thirteenth and fourteenth columns of the Second Schedule to this Order;
- (c) by inserting at the end of the Schedule thereto the items specified in the first column of the Third Schedule to this Order, and the maximum prices for such items specified in the second, third, fourth, fifth, sixth, seventh, eighth, ninth, tenth, eleventh, twelfth, thirteenth and fourteenth columns of such lastmentioned Schedule;
- (d) by omitting from the first column of the schedule thereto the items specified therein under the subheadings "Honey" and "Honey—Other Brands," and the prices for such items specified in the second, third, fourth, fifth, sixth, seventh, eighth, ninth, tenth, eleventh, twelfth, thirteenth and fourteenth columns of such Schedule;
- (e) by inserting in the Schedule thereto, immediately after the items appearing therein under the subheading "Golden Syrup," the items specified under the subheadings "Honey" and "Honey—Other Brands" in the first column of the Fourth Schedule to this Order and the maximum prices for such items specified in the second, third, fourth, fifth, sixth, seventh, eighth, ninth, tenth, eleventh twelfth, thirteenth and fourteenth columns of such lastmentioned Schedule.
