PRICES CONTROL ACT, 1948-1949.

Notice-Declaration No. 41.

J, ARTHUR VALENTINE RUTHERFORD ABBOTT, Attorney General and Minister of the Crown, for the time being charged with the administration of the Prices Control Act, 1948-1949, in pursuance of the powers conferred by section 14 of the said Act and the Prices Control Regulations, 1949, do hereby revoke Declaration No. 36, dated the 24th day of March, 1950, made under the said Act, and published in the *Government Gazette* on the 28th day of March, 1950, insofar as it relates to the goods specified in the Schedule to this Declaration No. 41.

PRICES CONTROL ACT, 1948-1949.

Notice-Declaration No. 42.

I. ARTHUR VALENTINE RUTHERFORD ABBOTT, Attorney General and Minister of the Crown, for the time being charged with the administration of the Prices Control Act, 1948-1949, in pursuance of the powers conferred by section 14 of the said Act and the Prices Control Regulations, 1949, do hereby declare the goods specified in the Schedule to this Declaration No. 42 to be declared goods for the purposes of the said Act and Regulations.

Schedule.

Fibres, Yarns, Threads and Fabrics.

Elastic.

Fabrics (excluding plastic fabrics not woven or knitted) of all kinds whether knitted, lockstitched or woven, including water-proofed or rubberised fabrics and piece goods of all kinds and descriptions.

Rubber cloth for car hoods.

Rubber thread.

Tyre cord and tyre fabric.

Clothing.

Clothing, garments and apparel (excluding men's and boys' felt hats and foundation garments other than brassieres) of all kinds and decriptions manufactured partly or wholly from wool or from materials containing wool.

Bathing costumes and trunks.

Women's woollen underwear.

Rubber.

Hose, rubber or plastic.

Rubber pads, soles and heels.

Rubber tyres and tubes.

Tyre rubber.

Miscellaneous.

Lead acid storage batteries and components thereof. Battery boxes.

(The subheadings shown in the above Schedule are to facilitate reference to goods which are the subject of this Declaration. They shall not be read or construed as limiting or defining the scope of any of the items under the subheadings or of the goods included in such items.)
