## HEALTH ACT, 1911-1952.

## Section 251.

Order requiring Persons having in their Possession or under their Control for Sale or Resale any Desiccated Coconut produced or reasonably suspected of having been Produced or Received from Papua.

PURSUANT to the powers conferred upon me by the Governor in Council at a meeting held on 19th August, 1953, I, Linley Henzell, Commissioner of Public Health, hereby order all persons having in their possession or under their control for sale or resale any desiccated coconut produced or reasonably suspected of having been produced or received from Papua to deliver such desiccated coconut to the person at the place and within the time specified in the Schedule hereunder:—

## Schedule.

## (a)—Person.

The Town Clerk of the Municipality or the Secretary of the Road Board within which the coconut is stored.

## (b)—Time.

On or before Friday, 28th August, 1953.

## (c)—Place.

The Office of the Municipality or Road Board of the district within which the coconut is stored.
