Melville Road Board—Town Planning Scheme.

Amendment and Amplification.

IT is hereby notified for public information in accordance with section 7 of the Town Planning Act, 1928-1955, that the resolution of the Melville Road Board, dated the 14th day of August, 1956, to amplify and amend their Town Planning Scheme gazetted on the 20th November, 1936, insofar as it applies to business sites, such additions to be in accordance with the schedule as enumerated hereunder, and which was advertised in the *Government Gazette* of the 16th, 23rd and 30th November, 1956, was approved by the Hon. Minister for Town Planning on the 20th March, 1957.

Addition to Scheme—The whole of lot 24, Swan Location 73, Canning Highway, Melville.

Provided that no lot or part thereof above referred to, shall be used for the purposes of erecting or establishing a petrol filling station and shall not be used for the erection of a dwelling unless such dwelling is erected at the same time as, or after a shop or business on the same lot.

The building line for any buildings erected thereon, and the areas set aside for vehicle parking space shall be in accordance with the deposited plan of the lot.
