THE Hon. Minister for Justice, being the responsible Minister of the Crown charged with the administration of the Local Courts Act, 1904-1964, and in exercise of the power conferred on him by section 10 of that Act, has appointed the days stated opposite the names of the Local Courts set out hereunder as the times at which the magistrate shall attend to hold those Courts respectively commencing from August, 1965, in lieu of the times previously appointed:—

Derby Local Court: First Wednesday in each month.

Wyndham Local Court: Thursday following the first Wednesday in each month.

Hall's Creek Local Court: Tuesday before the last Thursday in each month January to November inclusive and the third Tuesday in December.

Port Hedland Local Court:

- (i) Second Tuesday in each month and
- (ii) Last Thursday in each month January to November inclusive and the fourth Thursday in December.
