By-laws.

- Principal by-laws. 1. In these by-laws the Metropolitan Water Supply, Sewerage, and Drainage Board by-laws published in the *Government Gazette* on the 28th January, 1970, are referred to as the principal by-laws.
- By-law 11 amended. 2. By-law 11 of the principal by-laws is amended—
- (a) by adding after the by-law number "11." the sub-by-law designation "(1)";
 - (b) by adding after the word "building" appearing in line one and again in line two, the words "or a structure of any kind", in both cases; and
 - (c) by adding a sub-by-law as follows—
 - (2) No person shall carry out or commence to carry out any alteration to the natural surface of any land in a catchment area without the approval in writing of the Board.
