THE Fremantle Port Authority, acting pursuant to the provisions of the Fremantle Port Authority Act, 1902-1969, hereby makes the regulations set forth in the schedule hereunder.

Schedule. Regulations.

- Principal Regulations. 1. In these regulations, the regulations made by the Fremantle Port Authority, under the Fremantle Port Authority Act, 1902-1969, reprinted pursuant to the Re-printing of Regulations Act, 1954, and published as so re-printed in the *Government Gazette* on the 14th September, 1967, with all amendments up to and including the 14th February, 1966, and amended from time to time thereafter, by notices so published, are referred to as the principal regulations.
- Reg. 379 amended. 2. Regulation No. 379 of the principal regulations is amended by substituting for the numerals, "14" in the penultimate line, the numerals "23".
3. Passed by resolution of the Fremantle Port Authority at a meeting of the said Authority held on the 8th day of October, 1970.
