- (ii) if the worker does not leave any such dependants,
but leaves any dependants in part dependent upon
his earnings, such sum, not exceeding in any case
the amount payable under the foregoing pro-
visions, as may be agreed upon, or in default of
agreement may be determined, by proceedings under
this Act, to be reasonable and proportionate to
the injury to the said dependants; and
- (iii) if he leaves no dependants, the reasonable ex-
penses of his medical attendance and burial, the
cost of which may be awarded to and upon the
application of any person by whom the expenses
were properly incurred, or to whom the whole or
any part of the expenses is owed.
