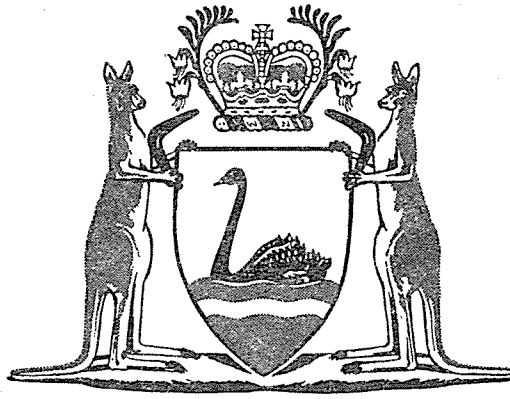

### NOTICE OF INTENTION TO RESUME LAND

*Improvement Plan No. 11—Metropolitan Region Planning Authority*

THE Minister for Town Planning and Urban Development hereby gives notice in accordance with the provisions of Section 17 (2) of the Public Works Act, 1902-1974, that it is intended to take or resume under Section 17 (1) of that Act, the pieces or parcels of land described in the Schedule hereto, and being all in the Perth Town District, for the purpose of the following public work, namely, Improvement Plan No. 11—Metropolitan Region Planning Authority, and that the said pieces or parcels of land are marked off on Plan P.W.D., W.A., 51500, which may be inspected at the Office of the Minister for Works, Perth. The additional information contained in the Schedule after the land descriptions is to define locality only and in no way derogates from the Transfer of Land Act description.
