## Public and Bank Holidays Act, 1972. PROCLAMATION

WESTERN AUSTRALIA, By His Excellency the Honourable Sir Francis Tro Wit: FRANCIS BURT, Lieutenant Governor and Administrator. [L.S.] L.S.] J.
