By-law No. 64—Town Planning Classification or Zoning By-law for the Land and/or Buildings in the North Perth/Mount Hawthorn/Wembley/Leederville Area being part of the City of Perth Municipal District—Amendment.

IN pursuance of the powers conferred upon it by the abovementioned Act and of all other powers enabling it the Council of the City of Perth hereby records having resolved on 21 June 1982 to make and submit for confirmation by the Governor the following amendment to By-law No. 64:—

That the following portion of land being

be and is hereby excised from No. 2 Zone Classification and reclassified and included in the No. 16 Zone Classification and that the North Perth/Mount Hawthorn/Wembley/Leederville Area Zoning Plan No. 64 be and is hereby amended accordingly.
