AMENDMENT ORDER (No. 6) 1990**

MADE by the Prices Commissioner under section 12.

Citation1. This order may be cited as the *Petroleum Products Pricing (Maximum Prices for Motor Fuel) Amendment Order (No. 6) 1990*.**Commencement**

2. This order shall take effect on 8 May 1990.

Interpretation

3. In this order—

“the principal order” means the *Petroleum Products Pricing (Maximum Prices for Motor Fuel) Order 1984**.
