**PETROLEUM PRODUCTS PRICING ACT 1983**  
**PETROLEUM PRODUCTS PRICING (MAXIMUM PRICES FOR MOTOR FUEL)**  
**AMENDMENT ORDER (No. 11) 1990**

MADE by the Prices Commissioner under section 12.

**Citation**

1. This order may be cited as the *Petroleum Products Pricing (Maximum Prices for Motor Fuel) Amendment Order (No. 11) 1990*.

**Commencement**

2. This order shall take effect on 26 June, 1990.

**Interpretation**

3. In this order—

“the principal order” means the *Petroleum Products Pricing (Maximum Prices for Motor Fuel) Order 1984\**.
