PETROLEUM PRODUCTS PRICING ACT 1983

PETROLEUM PRODUCTS PRICING (MAXIMUM PRICES FOR MOTOR FUEL) AMENDMENT ORDER (No. 22) 1990

Made by the Prices Commissioner under section 12.

Citation

1. This order may be cited as the *Petroleum Products Pricing (Maximum Prices for Motor Fuel) Amendment Order (No. 22) 1990*.

Commencement

2. This order shall take effect on 21 September 1990.

Interpretation

3. In this order—

“the principal order” means the *Petroleum Products Pricing (Maximum Prices for Motor Fuel) Order 1984*.*
