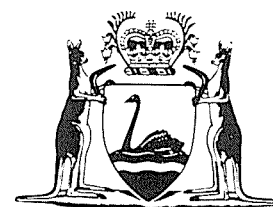

## PETROLEUM PRODUCTS PRICING ACT 1983

### PETROLEUM PRODUCTS PRICING (MAXIMUM PRICES FOR MOTOR FUEL) AMENDMENT ORDER (No. 34) 1990

Made by the Prices Commissioner under section 12.

#### Citation

1. This order may be cited as the *Petroleum Products Pricing (Maximum Prices for Motor Fuel) Amendment Order (No. 34) 1990*.

#### Commencement

2. This order shall take effect on 27 October 1990.

#### Interpretation

3. In this order—

“the principal order” means the *Petroleum Products Pricing (Maximum Prices for Motor Fuel) Order 1984*.\*

#### Clause 4 amended

(c) “90.2c” in paragraph (c) and substituting the following—

“ 88.6c ”.
