PETROLEUM PRODUCTS PRICING (MAXIMUM PRICES FOR MOTOR FUEL) AMENDMENT
ORDER (No. 46) 1990

Made by the Prices Commissioner under section 12.

Citation

1. This order may be cited as the *Petroleum Products Pricing (Maximum Prices for Motor Fuel) Amendment Order (No. 46) 1990*.

Commencement

2. This order shall take effect on 8 December 1990.

Interpretation

3. In this order—

“the principal order” means the *Petroleum Products Pricing (Maximum Prices for Motor Fuel) Order 1984**.
