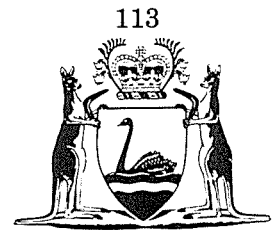

**ELECTORAL ACT 1907**

LEGISLATIVE COUNCIL GENERAL ELECTION 1993

1. Under section 65 of the *Electoral Act 1907* I give notice that on 8 January 1993 I received from His Excellency the Governor a warrant, under section 64 (2) of that Act, authorizing and directing me to proceed to issue writs for elections in all the electoral regions to elect—
  - (a) 7 members of the Legislative Council for each of the electoral regions known, respectively, as the North Metropolitan Region and the South West Region; and
  - (b) 5 members of the Legislative Council for each of the electoral regions known, respectively, as the South Metropolitan Region, the East Metropolitan Region, the Agricultural Region and the Mining and Pastoral Region.
2. Under section 64 (3) of the *Electoral Act 1907*, I have caused the writs for the elections to be issued.
3. The following dates have been appointed for the purposes of the general election—
  - (1) Close of nominations—Friday, 15 January 1993, at 6 p.m.
  - (2) Polling Day—Saturday, 6 February 1993.
  - (3) Return of writs—Friday, 12 March 1993.

**ELECTORAL ACT 1907**

LEGISLATIVE ASSEMBLY GENERAL ELECTION 1993

1. Under section 65 of the *Electoral Act 1907* I give notice that on 8 January 1993 I received from His Excellency the Governor a warrant, under section 64 (1) of that Act, authorizing and directing me to proceed to issue writs for elections in all the electoral districts to elect one member of the Legislative Assembly for each electoral district.
2. Under section 64 (3) of the *Electoral Act 1907*, I have caused the writs for the elections to be issued.
3. The following dates have been appointed for the purposes of the general election—
  - (1) Close of nominations—Friday, 15 January 1993, at 6 p.m.
  - (2) Polling Day—Saturday, 6 February 1993.
  - (3) Return of writs—Friday, 5 March 1993.
