### METROPOLITAN REGION SCHEME

#### The North West Corridor

Amendment No. 932/33.

File: 809-2-30-6 V3.

1. It is hereby notified for public information that the Metropolitan Planning Council, for and on behalf of the State Planning Commission and acting under delegated powers, having considered all submissions received in respect of the Amendment to the Metropolitan Region Scheme No. 932/33, first published in the *Government Gazette* on September 3, 1993, has determined that the Amendment be modified as detailed in the First Schedule hereto.

2. The Amendment, as modified, has been approved by His Excellency, the Governor, in accordance with the provisions of the Metropolitan Region Town Planning Scheme Act 1959.

3. The Minister for Planning has determined that copies of the modified Amendment and the accompanying report be made available for public inspection as from Wednesday 11 May 1994, to Friday 24 June 1994, during normal office hours at places mentioned in the Second Schedule hereto.

#### First Schedule

Metropolitan Region Scheme Map Sheet Number 3 is amended by substituting the proposed zones and reservations as shown on amendment Map Sheet Number 3/12m.

The purpose of the Amendment is to transfer land from the Rural Zone and Other Major Highways Reservation to the Urban Zone, Urban Deferred Zone, Central City Area Zone, Controlled Access Highway Reservation, Important Regional Roads Reservation, Parks and Recreation Reservation, Public Purposes Reservation, Private Recreation Reservation, Other Major Highways Reservation and Railways Reservation in the Alkimos-Eglinton area in the City of Wanneroo, to give statutory effect to the planning proposals for the Alkimos-Eglinton area of the North-West Corridor.
