**HERITAGE OF WESTERN AUSTRALIA ACT 1990****NOTICE OF ENTRY OF PLACES IN THE REGISTER OF HERITAGE PLACES**

Notice is hereby given in accordance with Section 51(2) of the *Heritage of Western Australia Act 1990* that, pursuant to directions from the Minister for Heritage, the places described in Schedule 1 have been entered in the Register of Heritage Places on a permanent basis with effect from today.

## Schedule 1

**Description of Place**

**Mission to Seamen Building** at 272 Marine Terrace, Geraldton; Lt 2558 on DP 174595 being the whole of the land contained in C/T V 1323 F 691.

**Moran's Wagin Hotel** at Cnr of Tudor & Tavistock Streets, Wagin; Lts 1, 2 and 40 on P 341 being the whole of the land contained in C/T V 2055 F 784 together with Lt 919 on DP 155922 being the whole of the land contained in C/T V 386 F 158A.

**Moreton Terrace & Point Leander Drive Fig Trees, Dongara** at Moreton Terrace & Point Leander Drive, Dongara; Lt 12 on D 88837 being the whole of the land contained in C/T V 2218 F 360 together with that ptn of the Moreton Terrace road reserve as is defined by HCWA Survey No 4367 as prepared by Cadgraphics WA.

**The Cliffe** at 25 Bindaring Parade, Peppermint Grove; Ptn of Swan Loc 84 & being (firstly) part of each of Lts 25, 26 & 27 on Plan 3783 (Sheet 1) & (secondly) part of each of Lts 28 & 29 on D 8903 & being the whole of the land in C/T V 1265 F 334.

**The New Church** at 176 Adelaide Terrace, East Perth; Lt 709 on DP 156945 being the whole of the land contained in C/T V 494 F 136a.

Pursuant to directions from the Minister for Heritage, notice is hereby given in accordance with Section 49(1) of the *Heritage of Western Australia Act 1990* that it is proposed that the places described in Schedule 2 be entered in the Register of Heritage Places. The Heritage Council invites submissions on the proposal which must be in writing & should be forwarded to the address below not later than 9 April 2004. The places will be entered in the Register on an interim basis with effect from today.

**Church of St Mary, Star of the Sea** at Cnr Rushton & Johnstone Streets, Carnarvon; Lt 337 on DP 222239 being the whole of the land contained in C/T V 179 F 126.

**Old Mill Theatre** at 429 Mends Street, South Perth; Perth Sub Lt 429 being the whole of the land contained in C/T V 574 F 69.
