**CONSERVATION AND LAND MANAGEMENT ACT 1984
MANAGEMENT PLAN FOR THE ROWLEY SHOALS MARINE PARK**

Under section 60(3) of the *Conservation and Land Management Act 1984* (CALM Act) notice is given that the draft management plan for the Rowley Shoals Marine Park has been approved with modifications by the Minister for the Environment on 8 December 2006.

Under section 14(9) of the CALM Act notice is also given that an indicative management plan, prepared in accordance with sections 13 and 14 of the CALM Act for the additions made to the Rowley Shoals Marine Park on 10 December 2004, has been approved with modifications by the Minister for the Environment on 8 December 2006.

The approved indicative management plan and the approved management plan for the Rowley Shoals Marine Park comprise the *Rowley Shoals Marine Park Management Plan 2007-2017*, which will come into operation on the day of publication of this notice in the Gazette.

Notice is given under sections 14(7) and 60(2) of the CALM Act of the following modifications approved by the Minister for the Environment—

- The boundaries of the following zones have been modified—
 - > Clerke Sanctuary Zone; and
 - > Clerke Lagoon Recreation Zone.
- Amendments to Table 2 (activities permitted in specific zones).
- Removal of Appendices I, II and III.
- Amendments to general text, objectives, management strategies and targets for the ecological and social values and other sections of the draft plan.
- Other minor changes were made to the text of the draft and indicative plans that will not significantly affect management of the marine park (i.e. formatting and minor text amendments).
