WEST COAST ROCK LOBSTER MANAGEMENT PLAN AMENDMENT (NO. 6) 2009

FD 1064/01 [945, 948]

Made by the Minister under section 54.

1. Citation

This instrument is the *West Coast Rock Lobster Management Plan Amendment (No. 6) 2009*.

2. Management plan amended

The amendments in this instrument are to the *West Coast Rock Lobster Management Plan 1993*.

3. Clause 9A amended

Clause 9A is amended—

(a) by deleting subclause (1)(c) and inserting instead—

“ (1)(c) A person must not set or pull a pot in the waters of zone B of the Fishery on any Friday during the period commencing on 1 December and ending on 14 April in any season. ”; and

(b) by deleting subclauses (3), (4) and (5) and inserting instead—

“ (3) Despite subclause (2)(a), a person must not set or pull a pot in the Fishery on 25 December or 1 January in any year.

(4) A person must not set or pull a pot in the waters of zone B of the Fishery at any time—

(a) during the period commencing on 28 December 2009 and ending on 31 December 2009; or

(b) during the period commencing on 4 January 2010 and ending on 7 January 2010.

(5) A person must not set or pull a pot in the waters of zone C of the Fishery at any time during the period commencing on 28 December 2009 and ending on 31 December 2009. ”.

4. Clause 9C amended

Clause 9C is amended by deleting “ 9A(1), 9A(3) or 9A(5) ” and inserting instead—

“ 9A(1), 9A(3), 9A(4) or 9A(5) ”.

5. Clause 9D amended

Clause 9D is amended by deleting “ 9A(1), 9A(3) and 9A(5) ” and inserting instead—

“ 9A(1), 9A(3), 9A(4) or 9A(5) ”.

6. Clause 9F amended

Clause 9F is amended—

(a) in subclause (1)(a) by deleting “ 9A(1)(b), 9A(1)(c), 9A(3) and 9A(5) ” and inserting instead—

“ 9A(1)(b), 9A(1)(c), 9A(3) and 9A(4) ”; and

(b) in subclause (1)(c) by deleting “ 9A(1), 9A(3) or 9A(5) ” and inserting instead—

“ 9A(1), 9A(3), 9A(4) or 9A(5) ”.

7. Clause 9H repealed

Clause 9H is repealed.

8. Clause 9I replaced

Clause 9I is deleted and the following clause is inserted instead—

“ **Exception to restrictions on the use of boats—setting pots at certain times**

9I. Subclauses 9E(1) and 9E(4) do not apply in respect of a boat in the waters of the Fishery on any Sunday where the boat is being used to set pots in accordance with clauses 9A(2) and 9A(3). ”.
