Medical Radiation Technologists Act 2006

An Act to —

- provide for the regulation of the practice of medical radiation technology and the registration of natural persons as medical radiation technologists;
- amend the Radiation Safety Act 1975;
- make consequential amendments to various Acts, and for related purposes.

The Parliament of Western Australia enacts as follows:

s. 1

Part 1 — Preliminary

1. Short title

This is the *Medical Radiation Technologists Act 2006*.

2. Commencement

- This Act comes into operation on a day fixed by proclamation. (1)
- Different days may be fixed under subsection (1) for different (2) provisions.

Terms used in this Act **3.**

In this Act, unless the contrary intention appears application means an application for registration; approved means approved by the Board in writing; area of medical radiation technology means —

- medical imaging technology;
- (b) nuclear medicine technology; or
- radiation therapy;

Board means the Medical Radiation Technologists Registration Board of Western Australia established by section 4;

certificate of registration means a certificate of registration issued under section 39;

committee means a committee established by the Board under this Act;

complainant means a person who lodges a complaint under section 52(1) or (2);

complaint means —

- a complaint lodged under section 52(1) or (2);
- a complaint referred under section 52(3); (b)

- (c) a matter the complaints assessment committee has determined under section 52(4) to deal with as if it were a complaint; and
- (d) a matter the Board has referred to the impairment review committee under section 61(3);

complaints assessment committee means the committee established under section 50;

condition includes restriction;

Corporations Act means the Corporations Act 2001 of the Commonwealth;

Director means the Director of the Office of Health Review under the *Health Services (Conciliation and Review) Act 1995*;

disciplinary matter means a matter referred to in section 48;

document includes any tape, disc or other device or medium on which information is recorded or stored;

impairment means —

- (a) mental disability;
- (b) injury;
- (c) physical illness;

impairment matter means a matter referred to in section 49;

impairment review committee means any committee established under section 51;

investigator means a person appointed under section 71;

legal practitioner has the meaning given to that term in the *Legal Practice Act 2003* section 3;

medical practitioner means a medical practitioner registered under the *Medical Practitioners Act 2008*;

medical radiation technologist means a person who is registered;

medical radiation technology means medical imaging technology, nuclear medicine technology or radiation therapy;

member of the Board includes a person acting under Schedule 1 clause 3:

officer, in relation to a body corporate, has the meaning given to "officer of a corporation" in the Corporations Act section 9 but does not include an employee of the body corporate unless the employee is concerned in the management of the body corporate;

presiding member means the presiding member of the Board referred to in section 6;

Radiological Council means the body established under the Radiation Safety Act 1975 section 13;

register means the register referred to in section 37;

registered means registered by the Board under this Act in respect of one or more areas of medical radiation technology;

registrar means the person engaged or employed to be registrar under section 16:

registration includes renewal of registration;

respondent means a person the subject of a complaint;

restricted title means —

- in relation to a medical radiation technologist who is registered in respect of the area of medical imaging technology, a title that consists of, or includes, or is an abbreviation or derivative of "medical imaging technologist" or "radiographer" but not "industrial radiographer";
- in relation to a medical radiation technologist who is (b) registered in respect of the area of nuclear medicine technology, a title that consists of, or includes, or is an abbreviation or derivative of "nuclear medicine technologist"; and
- in relation to a medical radiation technologist who is registered in respect of the area of radiation therapy, a

title that consists of, or includes, or is an abbreviation or derivative of "radiation therapist".

Division 1 — The Board

4. **Board established**

- A body called the Medical Radiation Technologists Registration (1) Board of Western Australia is established.
- (2) The Board —
 - (a) is a body corporate;
 - has perpetual succession and a common seal; and (b)
 - may sue and be sued in its corporate name.
- The Board does not represent, and is not an agent of, the Crown. (3)

5. Membership of Board

- (1) The Board consists of 8 members appointed by the Minister, of whom -
 - (a) 2 are to be medical radiation technologists registered in the area of medical imaging technology;
 - 2 are to be medical radiation technologists registered in the area of nuclear medicine technology;
 - 2 are to be medical radiation technologists registered in (c) the area of radiation therapy;
 - one is to be a person who has knowledge of and (d) experience in representing the interests of consumers; and
 - one is to be a legal practitioner.an Australian lawyer (within the meaning of that term in the Legal Profession Act 2008 section 3).
- Each member of the Board is to be a natural person. (2)

Part 2

6. Presiding member and deputy presiding member

The presiding member and the deputy presiding member of the Board are to be elected by the Board from amongst its members.

7. Constitution and proceedings

Schedule 1 has effect with respect to the constitution and proceedings of the Board.

8. Remuneration and allowances

A member of the Board, or of a committee, is to be paid such remuneration and allowances (if any) as the Minister, on the recommendation of the Minister for Public Sector Management, determines from time to time.

Division 2 — Functions and powers

9. **Functions**

The functions of the Board are as follows —

- to advise the Minister on matters to which this Act applies;
- to administer the scheme of registration under Part 4; (b)
- to support and promote public education and research in (c) relation to the practice of medical radiation technology;
- to monitor education in medical radiation technology, (d) and provide advice on that education to the Minister and to any other person or body involved in that education;
- to promote and encourage (e)
 - the continuing education of medical radiation technologists in the practice of medical radiation technology; and
 - increased levels of skill, knowledge and (ii) competence in the practice of medical radiation technology;

and

to perform other functions that are conferred on the (f) Board under this Act or any other Act.

10. **Powers**

The Board has all the powers it needs to perform its functions.

11. **Delegation by Board**

- The Board may delegate any power or duty of the Board under (1) another provision of this Act to
 - a member of the Board; (a)
 - (b) a committee or a member of a committee; or
 - (c) the registrar.
- The delegation must be in writing executed by the Board. (2)
- A person to whom a power or duty is delegated under this (3) section cannot delegate that power or duty.
- A person exercising or performing a power or duty that has been (4) delegated to the person under this section is to be taken to do so in accordance with the terms of the delegation unless the contrary is shown.
- Nothing in this section limits the ability of the Board to perform a function through the registrar or any other member of staff or an agent.

Division 3 — Relationship of Board with Minister

12. **Directions by Minister**

Subject to subsection (2), the Minister may, after consulting (1) with the Board, give directions in writing to the Board with respect to the performance of its functions either generally or in relation to a particular matter, and the Board is to give effect to any such direction.

- Relationship of Board with Minister
- (2) The Minister must not under subsection (1) direct the Board with respect to the performance of its functions in respect of
 - a particular person;
 - (b) a particular qualification; or
 - a particular application, complaint or proceeding.
- The text of a direction given under subsection (1) must be (3)
 - laid before each House of Parliament within 14 sitting days of that House after the direction is given; and
 - included in the annual report submitted by the Board (b) under section 25(1).

13. Minister to have access to information

(1) In this section —

> information means information specified, or of a description specified, by the Minister that relates to the functions of the Board.

- The Minister is entitled (2)
 - to have information in the possession of the Board; and
 - if the information is in or on a document, to have, and (b) make and retain copies of, that document.
- For the purposes of subsection (2) the Minister may (3)
 - request the Board to furnish information to the Minister; (a)
 - request the Board to give the Minister access to (b) information;
 - for the purposes of paragraph (b) make use of the staff of the Board to obtain the information and furnish it to the Minister.
- (4) The Board is to comply with a request under subsection (3) and make its staff and facilities available to the Minister for the purposes of subsection (3)(c).

- (5) The Minister is not entitled to have information under this section in a form that
 - (a) discloses the identity of a person involved in a particular application, complaint, investigation or other proceeding; or
 - (b) might enable the identity of any such person to be ascertained.

unless that person has consented to the disclosure.

Division 4 — Committees

14. Committees

- (1) In addition to the complaints assessment committee and the impairment review committee the Board may from time to time establish any other committee.
- (2) The Board may
 - (a) determine the functions, membership and constitution;
 - (b) appoint such members and other persons as it thinks fit to be members; and
 - (c) give directions with respect to the functions and procedures,

of a committee established under this section.

- (3) A committee is to comply with a direction given to it under subsection (2)(c).
- (4) At the request of the Board, a committee established under this section is to report on the performance of its functions to the Board, in accordance with the Board's request.

15. Provisions relating to committees

(1) Each member of a committee is to be a natural person.

Part 2

- The Board may remove a person from membership of a committee and may reconstitute or discharge a committee established by the Board.
- (3) A committee is to ensure that an accurate record is kept and preserved of the proceedings of each meeting of the committee and of each resolution passed by the committee.
- (4) Subject to this Act, a committee may determine its own procedures.
- A person with special knowledge or experience may be invited (5) to act in an advisory capacity to a committee if the committee is of the opinion that the person will assist the committee in the performance of its functions and the Board has approved the invitation.

Division 5 — Registrar and other staff

16. Registrar

- (1) The Board is to engage or employ a person to be the registrar.
- The registrar has the functions that are conferred under this Act (2) or that the Board directs the registrar to perform.
- (3) The registrar may delegate to a person engaged or employed by the Board any power or duty of the registrar under another provision of this Act.
- (4) The delegation must be in writing executed by the registrar.
- A person to whom a power or duty is delegated under this (5) section cannot delegate that power or duty.
- (6) A delegate exercising or performing a power or duty that has been delegated to the person under this section is to be taken to do so in accordance with the terms of the delegation unless the contrary is shown.

The Board may engage or employ persons to provide such professional, technical or other assistance that the Board considers necessary to enable it to perform its functions.

Division 6 — General

18. **Notifications to the Radiological Council**

- (1) The Board is to give the Radiological Council written advice of the following matters
 - the cancellation of the registration of a medical radiation technologist and the removal of that person's name from the register under this Act;
 - the making of an order under section 55(1) or (3), (b) together with a copy of the order;
 - the suspension or revocation of the suspension from the (c) practice of medical radiation technology under this Act of a medical radiation technologist, whether generally or in relation to any specified area, circumstances or service:
 - the imposition, variation or revocation of any condition on registration or the practice of medical radiation technology under this Act of a medical radiation technologist;
 - the making of an allegation to the State Administrative (e) Tribunal under this Act.
- (2) The advice referred to in subsection (1) is to be given no later than 14 days after the occurrence of the matter referred to in that subsection.

19. Duty not to make improper use of information

A member or former member of the Board or a member or former member of a committee must not, whether within or

outside the State, make improper use of information acquired by virtue of that position to gain, directly or indirectly, an advantage for himself or herself or for any other person.

Penalty: a fine of \$5 000.

20. Meetings and minutes of meetings

- (1) Subject to this section, every meeting of the Board is to be open to members of the public.
- (2) Despite subsection (1)
 - (a) the Board may of its own initiative order that in any particular case a meeting, or part of a meeting, of the Board is to be closed; and
 - (b) where a meeting of the Board concerns a proceeding under Part 5 relating to a disciplinary or impairment matter, a person to whom the proceedings relate may request that the meeting, or part of the meeting, be closed.
- (3) The Board is to consider a request under subsection (2)(b) and may order that the meeting, or part of the meeting, be closed if it is of the opinion that such an order is in the best interests of the parties involved or the maintenance of professional standards.
- (4) The minutes of a meeting of the Board are to be open for inspection at its principal place of business by members of the public during normal office hours without fee, other than minutes relating to
 - (a) proceedings under Part 5 relating to a disciplinary or impairment matter;
 - (b) a matter determined to be confidential under subsection (6); or
 - (c) a meeting, or part of a meeting, that the Board ordered be closed under subsection (2)(a) or (3).

A person may, on payment of the fee prescribed by the regulations, if any, obtain a copy of any minutes of the Board available for inspection under subsection (4).

(6) The Board may determine that a matter is confidential if it considers that its disclosure is likely to infringe the reasonable privacy of any person.

21. **Execution of documents by Board**

- (1) The Board is to have a common seal.
- A document is duly executed by the Board, if (2)
 - the common seal of the Board is affixed to it in accordance with subsections (3) and (4); or
 - it is signed on behalf of the Board by a person or persons (b) authorised by the Board to do so under subsection (5).
- (3) The common seal of the Board is not to be affixed to any document except as authorised by the Board.
- (4) The common seal of the Board is to be affixed to a document in the presence of 2 members of the Board and each of them is to sign the document to attest that the common seal was so affixed.
- The Board may, by writing under its seal, authorise (5)
 - a member or members of the Board; or
 - (b) a member or members of staff.

to sign documents on behalf of the Board, either generally or subject to such conditions as are specified in the authorisation.

- A document executed under this section without the common (6) seal of the Board is not to be regarded as being a document under seal.
- A document purporting to be executed in accordance with this section is to be presumed to be duly executed until the contrary is shown.

(8) When a document is produced bearing a seal purporting to be the common seal of the Board, it is to be presumed that the seal is the common seal of the Board until the contrary is shown.

Part 3 — Finance and reports

22. Funds of the Board

- (1) The funds of the Board consist of
 - fees received by the Board;
 - grants (if any) by the State, and all gifts and donations (b) made to the Board, but subject to any trusts declared in relation to the grants, gifts or donations;
 - penalties, costs and expenses received under section 60 or 82; and
 - (d) other money or property lawfully received by the Board in connection with the performance of its functions.
- The funds of the Board may be applied (2)
 - for the purposes of the administration and enforcement of this Act, including the remuneration of members of the Board and committees and of the registrar and other persons engaged or employed by the Board;
 - for the payment of examinations and reports in (b) accordance with section 65(3);
 - for the furtherance of education, including public (c) education, and research in relation to the practice of medical radiation technology;
 - by way of contribution to any professional body for (d) medical radiation technologists for the development by that body of professional standards; and
 - for any other purpose that the Board may recommend (e) and the Minister may approve to enable the Board to perform its functions.

23. Accounts

(1) The Board is to cause to be kept proper accounts and records of the transactions and affairs of the Board and is to prepare

(2) The financial statements are to be prepared on an accrual basis unless the Board determines otherwise.

24. Audit

The accounts and financial statements of the Board are to be audited at least once a year, at the expense of the Board, by a registered company auditor (as defined in paragraph (a) of the definition of that term in the Corporations Act section 9) appointed by the Board with the prior approval of the Minister.

25. Annual report and other reports

- The Board, not later than 31 December in each year, is to make (1) and submit to the Minister an annual report of its proceedings for the preceding year ending on 30 June together with a copy of its financial statements for that year and the auditor's report on those statements.
- The Board's annual report must include details of (2)
 - the number, nature, and outcome, of
 - investigations and inquiries undertaken under this Act during the year to which the report relates; and
 - matters that have been brought before the State (ii) Administrative Tribunal by the Board during the year to which the report relates;
 - the number and nature of matters referred to in (b) paragraph (a) that are outstanding;
 - (c) any trends or special problems that may have emerged;
 - forecasts of the workload of the Board in the year after (d) the year to which the report relates; and
 - any proposals for improving the operation of the Board. (e)

- (3) The Minister is to cause a copy of the Board's annual report and financial statements and of the auditor's report submitted under subsection (1) to be laid before each House of Parliament within 14 sitting days of that House after receipt of the report by the Minister.
- (4) The Board is to ensure that after subsection (3) has been complied with copies of the reports and statements referred to in that subsection are available on request for inspection at its principal place of business.

Part 4 — Registration of medical radiation technologists

Division 1 — Registration

26. Natural persons may be registered

Registration under this Act may be granted only to a natural person.

27. Registration

- (1) The Board is to register an applicant in respect of one or more areas of medical radiation technology if satisfied that the applicant has —
 - (a) complied with the requirements of subsection (2) relevant to the area in respect of which registration is applied for; and
 - (b) paid the registration fee, if any, prescribed by the regulations.
- (2) The requirements for registration are that the applicant
 - is a fit and proper person to be registered as a medical radiation technologist;
 - has not been convicted of an offence the nature of which (b) renders the person unfit to practise as a medical radiation technologist;
 - has adequate knowledge of the English language both written and oral;
 - has sufficient physical capacity, mental capacity and (d) skill to practise medical radiation technology;
 - subject to subsection (3), has acquired such knowledge and has such practical experience in the relevant area of medical radiation technology that in the opinion of the Board is sufficient to enable that person to perform

- efficiently the duties of a medical radiation technologist in that area; and
- holds a qualification prescribed by the rules as a qualification for registration as a medical radiation technologist relevant to the area in respect of which registration is applied for or a qualification that in the opinion of the Board is equivalent to such a qualification.
- (3) Subsection (2)(e) does not apply to a person who, having been awarded a qualification referred to in subsection (2)(f) within the 5 years preceding the application, is applying to the Board, for the first time, for registration under subsection (1).
- **(4)** The Board may impose such conditions on registration under subsection (1) as the Board reasonably requires to ensure the competent and safe practice of medical radiation technology.
- A condition imposed under subsection (4) may apply (5) indefinitely or for a period of time specified by the Board in the written notice.
- (6) The Board may, on its own motion or on the application of a person the subject of a condition imposed under this section, on reasonable grounds, revoke or vary the condition.

28. **Provisional registration**

- The Board may provisionally register an applicant in the area or (1) areas of medical radiation technology in respect of which the person has applied for registration if satisfied that
 - the applicant has applied to be registered under section 27 in respect of the area or areas;
 - (b) the requisite evidence is likely to be produced to enable the Board to be satisfied as to the matters set out in section 27(2) in respect of the area or areas; and
 - the applicant has paid the registration fee, if any, prescribed by the regulations.

- Provisional registration has effect for a period of 3 months beginning on the day on which it is granted unless earlier cancelled.
- (3) The Board may impose such conditions on registration under subsection (1) as the Board reasonably requires to ensure the competent and safe practice of medical radiation technology by the medical radiation technologist.
- If the Board, before the period referred to in subsection (2) expires, has reason to believe that a person granted provisional registration is not entitled to be registered as a medical radiation technologist under section 27 in the area or areas of medical radiation technology in respect of which the person has applied for registration, the Board may, without prejudice to the person's application to be registered, cancel the person's provisional registration.

29. Conditional registration at the discretion of the Board

- (1) The Board may grant a person conditional registration as a medical radiation technologist in the area or areas of medical radiation technology in respect of which the person has applied for registration if
 - the Board is satisfied that the person meets the requirements of section 27(2)(a), (b), (c) and (d) in respect of the area or areas;
 - the Board is satisfied that (b)
 - the person meets the requirements of section 27(2)(e) in respect of the area or areas and that the requisite evidence is likely to be produced to enable the Board to be satisfied as to the matters set out in section 27(2)(f) in respect of the area or areas;
 - the person, recognised by the Board as being a (ii) person of eminence within the area of medical radiation technology, desires registration for the

- purpose of enabling the person to teach and demonstrate methods and techniques of medical radiation technology in the area or areas; or
- the person desires registration to enable the (iii) person to undertake particular duties of medical radiation technology of limited duration in the area or areas;

and

- the applicant has paid the registration fee, if any, (c) prescribed by the regulations.
- Conditional registration (2)
 - has effect until the day specified in the certificate of (a) registration (unless registration is earlier cancelled by the Board) but that day is in no case to be later than 12 months after the issue of the certificate; and
 - (b) is not renewable.
- (3) Conditional registration, and the practice of medical radiation technology by a medical radiation technologist registered under this section, may be made subject to such conditions as the Board imposes in any particular case.
- (4) The Board may at any time cancel a conditional registration.
- The Board may, on its own motion or on the application of a (5) person the subject of a condition imposed under this section, on reasonable grounds, revoke or vary the condition.

30. Professional indemnity insurance

(1) In this section —

> professional indemnity insurance means professional indemnity insurance that meets the minimum terms and conditions approved by the Board.

- (2) Without limiting the Board's powers under section 27, 28 or 29, the Board may impose both of the following conditions as conditions of registration under section 27, 28 or 29
 - (a) that
 - (i) the medical radiation technologist must hold professional indemnity insurance;
 - (ii) the professional care and services provided by the medical radiation technologist must be covered by professional indemnity insurance; or
 - (iii) the medical radiation technologist must be specified or referred to in professional indemnity insurance, whether by name or otherwise, as a person to whom the professional indemnity insurance extends even though the medical radiation technologist is not a party to the professional indemnity insurance;
 - (b) that the professional indemnity insurance must meet the minimum terms and conditions approved by the Board.
- (3) A condition imposed under this section may apply indefinitely or for a period of time specified by the Board in the written notice of the decision given under section 98.
- (4) The Board may, on its own motion or on the application of a person the subject of a condition imposed under this section, on reasonable grounds, revoke or vary the condition.

31. Application

- (1) An application is to
 - (a) be in writing;
 - (b) be made in an approved manner and form;
 - (c) specify the area, or areas, of medical radiation technology in which the applicant seeks registration; and
 - (d) be accompanied by the application fee, if any, prescribed by the regulations.

Part 4 Registration of medical radiation technologists

Division 1 Registration

s. 32

- (2) The applicant must provide the Board or the registrar with such further information as the Board or the registrar requires, in any particular case, and if required by the Board or the registrar must verify the information by statutory declaration.
- The Board may, in writing, require an applicant for registration (3) to attend before the Board for the purpose of satisfying the Board as to a matter relevant to the application and, if the person fails to attend, may refuse the application.
- (4) The Board may refuse to register a person who does not comply with this section.

32. **Effect of registration**

Subject to this Act and the Radiation Safety Act 1975, registration confers on the person registered the right to carry on in the State the practice of medical radiation technology under a restricted title.

33. **Duration of registration**

Subject to this Act, registration —

- has effect for the period prescribed by the regulations; and
- (b) may be renewed in accordance with the regulations for a further period prescribed by the regulations.

34. Renewal of registration

- (1) A medical radiation technologist must pay to the Board a fee prescribed by the regulations for the renewal of registration, and if the fee is not paid on or before the day on which it falls due under the regulations
 - the person ceases to be registered; and
 - the person's name must be removed from the register. (b)
- A person whose name is removed from the register under subsection (1) may at any time pay to the Board all fees that are

- in arrears, and all fees that would be in arrears if the person had continued to be registered, together with any additional amount prescribed by the regulations for the purposes of this subsection, and is then to be entitled, subject to this Act, to have his or her registration renewed and the name restored to the register.
- (3) For the purposes of Part 5, the registration of a person whose name is restored to the register under subsection (2) is taken to have continued during the period that the person's name was removed from the register under subsection (1).
- (4) The Board is to give written notice of the renewal fee to a medical radiation technologist, sent to that medical radiation technologist's address as recorded in the register, at least 42 days before the fee falls due under the regulations.
- A person may apply to the Board for the remission of fees (5) payable by the person under this section that are in arrears, and the Board may remit those fees in whole or in part.

35. Application for registration by a person whose registration has been cancelled under section 79(1)(i)

- (1) In this section
 - disqualified person means a person whose registration has been cancelled and name removed from the register under section 79(1)(i).
- A disqualified person may not apply for registration in any area (2) of medical radiation technology for a period of 2 years after that person's registration was cancelled.
- (3) The Board cannot grant an application for registration by a disqualified person unless it has applied for, and obtained, the approval of the State Administrative Tribunal to do so.
- Registration of, and the practice of medical radiation technology (4) by, a disqualified person may be made subject to such conditions as the Board in any particular case imposes.

Part 4 Registration of medical radiation technologists

Division 2 The register

s. 36

36. Conflict or inconsistency between conditions imposed under the *Radiation Safety Act 1975* and this Act

- (1) If there is any conflict or inconsistency between a condition
 - (a) imposed on a medical radiation technologist under this Act; and
 - (b) imposed on a licence held by the medical radiation technologist under the *Radiation Safety Act 1975*,

then —

- (c) the condition imposed on the licence prevails (whether that condition was imposed before or after the condition imposed under this Act); and
- (d) the condition imposed under this Act is of no effect to the extent of the conflict or inconsistency.
- (2) For the purposes of subsection (1), a conflict or inconsistency does not exist merely because the condition imposed under this Act imposes more stringent measures or a higher duty or standard in respect of a particular matter or aspect of practice.

Division 2 — The register

37. The register

The Board is required to keep an accurate and up to date register of all medical radiation technologists in such manner and form as the Board determines and in respect of each medical radiation technologist is to record —

- (a) the name of that medical radiation technologist;
- (b) the area, or areas, of medical radiation technology in respect of which the medical radiation technologist is registered;
- (c) the business, or other, address of that medical radiation technologist;

- particulars of all of the qualifications in medical (d) radiation technology recognised by the Board and held by that medical radiation technologist;
- the provision of this Act under which the medical radiation technologist is registered;
- (f) any conditions applying to the registration;
- details of the exercise of any power under Part 5 in (g) respect of that medical radiation technologist; and
- such other information, if any, as is prescribed by the (h) regulations.

38. **Inspection of register**

- The register must be kept in the office of the registrar. (1)
- (2) The register must be available for inspection by members of the public during normal office hours.
- The register may be made available for inspection by members (3) of the public on an internet website maintained by the Board.
- A person may, on application to the registrar in respect of the (4) register or an entry in the register, and payment of the fee prescribed by the regulations, if any, obtain a certified copy of the register or the entry.
- (5) No fee is payable under subsection (4) if the application is made
 - by an officer of the department of the Public Service (a) principally assisting the Minister in the administration of this Act: and
 - for the purpose of carrying out the functions of an (b) officer of that department.

Part 4 Registration of medical radiation technologists

Division 2 The register

s. 39

39. Certificate of registration

- (1) On the registration of a person the Board is to issue to that person a certificate of registration in an approved form.
- (2) Where a person's registration is cancelled in an area but not all areas of medical radiation technology, the Board is to revoke the person's certificate of registration and issue that person a new certificate of registration in an approved form.
- (3) In the absence of evidence to the contrary a valid certificate of registration is evidence that the person to whom the certificate is issued is registered as a medical radiation technologist in respect of an area, or areas, of medical radiation technology, as specified in the certificate.

40. Voluntary removal from register and cancellation of registration or cancellation of area or areas of medical radiation technology

- (1) A medical radiation technologist may, in writing, request the registrar to
 - (a) cancel his or her registration as a medical radiation technologist in all areas of medical radiation technology and remove his or her name from the register; or
 - (b) if he or she is registered in respect of more than one area of medical radiation technology, cancel the registration in respect of a specified area or areas but not all areas.
- (2) Upon receipt of a request under subsection (1) the registrar is to refer the request to the Board and, if the Board so approves, is to accede to the request.
- (3) This section does not apply to a medical radiation technologist who is the subject of proceedings under Part 5.

41. Removal of name and cancellation of registration of person in certain circumstances

- (1) Subject to subsections (2) and (3), the Board is to cancel the registration of a medical radiation technologist in an area of medical radiation technology and direct the registrar to remove from the register the name of the medical radiation technologist in that area if the Board is satisfied that that person
 - (a) has not practised medical radiation technology in that area in the preceding period of 5 years; and
 - (b) has not maintained current knowledge and skills in medical radiation technology in that area at an approved level.
- (2) If the Board proposes to give a direction under subsection (1), the Board is to give the person written notice of the proposal and the reasons for the proposal.
- (3) A notice given under subsection (2) must state that within 28 days after the notice is given, the person to whom it is given may make written representations to the Board concerning the proposal, and the Board is not to give the direction without considering any representations received within that period.
- (4) If, after a direction under subsection (1), a person will not be registered in relation to any area of medical radiation technology, the Board is also to direct the registrar to remove the name of that person from the register.

42. Effect of removal of name from register

If the name of a registered person is removed from the register under a provision of this Act, that person ceases to be registered.

Division 3 — Notifications to Board

43. Change of address

A medical radiation technologist must give the registrar written (1) advice of any change to the address that is recorded in the register in relation to the person.

Penalty: a fine of \$1 000.

The advice referred to in subsection (1) must be given no later (2) than 30 days after the change to the address.

44. Loss of qualifications

A medical radiation technologist must give the registrar written (1) advice if a qualification that enabled the person to be registered is withdrawn or cancelled by the body that conferred the qualification.

Penalty: a fine of \$1 000.

(2) The advice referred to in subsection (1) must be given no later than 90 days after the withdrawal or cancellation.

45. **Insolvency**

(1) In subsection (2) —

> insolvent means a person who is an insolvent under administration as defined in the Corporations Act section 9.

A medical radiation technologist must, within 7 days of (2) becoming an insolvent, give the registrar written advice of the insolvency.

Penalty: a fine of \$5 000.

46. Civil or criminal proceedings

- (1) A medical radiation technologist must give the registrar written advice of any of the following matters within 14 days after
 - (a) any civil proceedings claiming damages or other compensation arising out of the practice of medical radiation technology;
 - (b) any criminal proceedings for an offence arising out of the practice of medical radiation technology,

are commenced against that medical radiation technologist. Penalty: a fine of \$5 000.

- (2) A medical radiation technologist must give the registrar written advice of any of the following matters within 14 days after
 - (a) any proceedings of a kind referred to in subsection (1) commenced against that medical radiation technologist are withdrawn or settled:

47. Information about professional indemnity insurance

- (1) If it is a condition of a medical radiation technologist's registration that
 - (a) the medical radiation technologist must hold professional indemnity insurance;
 - (b) the professional care and services provided by the medical radiation technologist must be covered by professional indemnity insurance; or
 - (c) the medical radiation technologist must be specified or referred to in professional indemnity insurance, whether by name or otherwise, as a person to whom the professional indemnity insurance extends even though

the medical radiation technologist is not a party to the professional indemnity insurance,

the medical radiation technologist must give the registrar written advice —

- (d) if the professional indemnity insurance is cancelled; or

- (a) that a person has contravened a condition applying to that person's registration or the practice of medical radiation technology by that person;

 - (ii) acted incompetently;
 - (iii) acted improperly;
 - (iv) breached this Act or the *Radiation Safety Act 1975*;
 - (v) failed to comply with an undertaking given to the Board under this Act;
 - (vi) provided services that were excessive, unnecessary or not reasonably necessary for the recipient's wellbeing;
- (c) that a person has been convicted of an offence the nature of which renders the person unfit to practise as a medical radiation technologist.

49. Impairment matters

The following are impairment matters —

- (a) that a person is affected by his or her use of or dependence on alcohol or a drug to such an extent that the ability of the person to practise as a medical radiation technologist is or is likely to be affected;
- (b) that a person suffers from an impairment to such an extent that the ability of the person to practise as a

medical radiation technologist is or is likely to be affected.

Division 2 — Committees

50. Complaints assessment committee

- (1) The Board is to establish a committee to be known as the complaints assessment committee.

 - a medical radiation technologist (who may be a member of the Board);
 - a person who is not a medical radiation technologist and (b) is not qualified to be registered as a medical radiation technologist;

- (5) The complaints assessment committee is not to make a determination under subsection (4) unless it is of the opinion that

 - (b) in respect of a person who was a medical radiation technologist when the disciplinary matter allegedly occurred, there is cause to investigate whether a disciplinary matter occurred.

53. Complaints assessment committee to determine action required

- (1) The complaints assessment committee is to decide in respect of a complaint
 - (a) if the committee is of the opinion that the complaint requires action under Division 4, to refer it to the Board for action under that Division;
 - (b) to reject the complaint under section 54;

54. Complaints assessment committee may reject certain complaints

- (1) The complaints assessment committee may at any time before deciding to
 - refer a complaint to the impairment review committee (a) under section 53(1)(d); or
 - make a recommendation to the Board under (b) section 53(3) or 58,

reject a complaint if it is of the opinion that the complaint is frivolous, vexatious or without substance.

Within 7 days of making a decision under subsection (1), the (2) complaints assessment committee is to give written notice to the complainant, if any, that the complaint is rejected and in the notice is to give short particulars of the reasons for the decision.

Division 4 — Summary orders of Board

55. Interim orders by Board

- (1) If the Board is of the opinion that an activity of a medical radiation technologist involves or will involve a risk of imminent injury or harm to the physical or mental health of any person, the Board may, without further inquiry, do any or all of the following
 - (a) give to the medical radiation technologist who is carrying on that activity an order prohibiting the carrying on of the activity for a period of not more than 30 days;
 - (b) give to the medical radiation technologist an order to comply, for a period of not more than 30 days, with such conditions as the Board thinks fit in relation to the practice of medical radiation technology by that medical radiation technologist;
 - (c) give to the medical radiation technologist an order suspending the person from the practice of medical radiation technology either generally or in relation to any specified area, circumstances or service, for a period of not more than 30 days.
- (2) An order made under subsection (1) must
 - (a) state that the Board is of the opinion that the activity of the medical radiation technologist involves or will involve a risk of imminent injury or harm to the physical or mental health of any person;
 - (b) specify the activity that in the Board's opinion involves or will involve the risk and the matters that give or will give rise to the risk; and
 - (c) advise that, within 14 days of the making of the order, the Board will revoke the order or make an allegation about the matter to the State Administrative Tribunal.

- (3) The Board may, by subsequent order given to the person to whom the order made under subsection (1) was given, revoke or vary the original order at any time before making an allegation about the matter to the State Administrative Tribunal under section 56.
- **(4)** The Board may deal under this section with a complaint even if—

59. Role of Board

- person concerned to pay such costs and expenses of or incidental to the proceedings as the Board thinks fit.
- (3) Where any penalty, costs or expenses are ordered to be paid under this section the amount ordered to be paid is recoverable in any court of competent jurisdiction as a debt due to the Board.
- (4) Within 7 days of making a decision under subsection (1)(d) to (g) or (2), the Board is to give written notice to the complainant, if any, and the respondent of the decision together with short particulars of the reasons for the decision.

Division 6 — Impairment matters

61. Request by medical radiation technologist for imposition of condition

- (1) A medical radiation technologist who believes that his or her ability to practise medical radiation technology is affected because of an impairment matter may ask the Board to impose a condition with respect to his or her registration.
- (2) If the Board and the medical radiation technologist agree upon the condition to be imposed, the Board is to impose that condition with respect to his or her registration.
- (3) If the Board and the medical radiation technologist do not agree upon the condition to be imposed, the Board is to refer the matter to the impairment review committee for investigation under this Division.

62. Revocation of condition

The Board may revoke a condition imposed under section 61 if the medical radiation technologist satisfies the impairment review committee that his or her ability to practise medical radiation technology is no longer affected because of the impairment matter that gave rise to the imposition of the condition.

64. Medical radiation technologist to be notified about investigation

- (1) The impairment review committee is to give written notice of the investigation to the medical radiation technologist to whom the complaint relates.

 - (a) advise the medical radiation technologist of the nature of the impairment matter to be investigated;
 - (b) if the impairment review committee considers that an examination of the medical radiation technologist is necessary, ask the medical radiation technologist to advise the committee as to whether or not he or she will agree to undergo an examination relating to the impairment matter within a period specified by the committee in the notice; and
 - (c) contain a brief summary of the effect of this Division.

65. Examination

- (3) The Board is to pay for an examination conducted under this section and a report provided under section 66.

66. Report of examination

- (1) A medical practitioner who conducts an examination under section 65 is to give a report of the examination to the impairment review committee and, not more than 7 days later, the committee is to give a copy of the report to the medical radiation technologist.

- The Board is to consider a recommendation of the impairment (1) review committee and may
 - decide not to take any action; (a)
 - take any action to which the medical radiation technologist consented under section 67(2); or
 - (c) make an allegation about the complaint to the State Administrative Tribunal.
- For the purpose of taking action to which the medical radiation technologist consented under section 67(2), the Board may
 - impose the conditions to which the medical radiation technologist consented;
 - suspend the medical radiation technologist from the (b) practice of medical radiation technology for the period specified by the impairment review committee; or
 - obtain an undertaking from the medical radiation technologist to undergo the counselling specified by the impairment review committee,

as the case may require.

Within 7 days of making a decision under subsection (1) or (2), (3) the Board is to give written notice to the medical radiation

Division 7 — Investigator's role and powers

70. Interpretation

In this Division —

appointing body, in relation to an investigator, means the Board or the complaints assessment committee which appointed the investigator.

71. Investigator

- (1) The Board or the complaints assessment committee may appoint a person to investigate a complaint and report to the Board or committee.
- (2) An appointing body is to issue to each investigator it appoints a certificate of appointment in an approved form.
- (3) A certificate purporting to have been issued under this section is evidence in any court of the appointment to which the certificate purports to relate.

72. Report of investigator

- (1) An investigator is to
 - (a) within such period as the appointing body requires prepare a report on the investigation, and make recommendations as to the manner in which the complaint should be dealt with; and
 - (b) immediately after preparing the report, provide the appointing body with a copy of the report.
- (2) The investigator is to return his or her certificate of appointment at the time the appointing body is provided with a copy of the report.

73. Powers of investigator

- (1) An investigator may for the purposes of an investigation
 - (a) enter and inspect the premises named in a warrant issued under section 75(1), and exercise the powers authorised under section 75(2)(b) and (c);
 - (b) require a person to produce to the investigator any document or other thing concerning the investigation that is in the possession or under the control of the person;
 - (c) inspect any document or other thing produced to the investigator and retain it for such reasonable period as the investigator thinks fit, and make copies of a document or any of its contents;
 - (d) require a person
 - (i) to give the investigator such information as the investigator requires; and
 - (ii) to answer any question put to that person, in relation to the matter the subject of the investigation; and
 - (e) exercise other powers conferred on an investigator by the regulations.
- (2) A requirement made under subsection (1)(b)
 - (a) must be made by notice in writing given to the person required to produce the document or other thing;
 - (b) must specify the time at or within which the document or other thing is to be produced;
 - (c) may, by its terms, require that the document or other thing required be produced at a place and by means specified in the requirement; and
 - (d) where the document required is not in a readable format, is to be treated as a requirement to produce
 - (i) the document itself; and

- (ii) the contents of the document in a readable format.
- (3) A requirement made under subsection (1)(d)
 - (a) may be made orally or by notice in writing served on the person required to give information or answer a question, as the case may be;
 - (b) must specify the time at or within which the information is to be given or the question is to be answered, as the case may be; and
 - (c) may, by its terms, require that the information or answer required
 - (i) be given orally or in writing;
 - (ii) be given at or sent or delivered to a place specified in the requirement;
 - (iii) in the case of written information or answers be sent or delivered by means specified in the requirement; or
 - (iv) be verified by statutory declaration.
- (4) If under subsection (1)(b) an investigator requires a person to produce any document or other thing concerning the investigation that is in the possession or under the control of the person, the investigator is to inform that person that the person is required under this Act to produce the document or thing.
- (5) If under subsection (1)(d) an investigator requires a person to give information or answer a question, the investigator is to inform that person that the person is required under this Act to give the information or answer the question.
- (6) An investigator is to produce his or her certificate of appointment if requested to do so by a person in respect of whom the investigator has exercised, or is about to exercise, a power under this section.

74. Warrant to enter premises

- (1) If the Board has determined in a particular case that an investigator has reasonable grounds for believing that entry to premises is necessary for the purpose of substantiating a complaint that may involve a threat to the physical or mental health of a person the investigator may apply to a magistrate for a warrant to be issued in respect of those premises.
- An application for a warrant must (2)
 - (a) be in writing;
 - (b) be accompanied by a notice in writing from the Board stating that it has determined in the particular case that the investigator has reasonable grounds for believing that entry to premises is necessary for the purpose of substantiating a complaint that may involve a threat to the physical or mental health of a person;
 - set out the grounds for seeking the warrant; and (c)
 - describe the premises that are to be entered.
- A magistrate to whom an application is made under this section (3) is to refuse it if
 - the application does not comply with the requirements of this Act; or
 - (b) when required to do so by the magistrate, the investigator does not give to the magistrate more information about the application.
- The information in an application or given to a magistrate under (4) this section must be verified before the magistrate on oath or affirmation or by affidavit, and the magistrate may for that purpose administer an oath or affirmation or take an affidavit.

75. Issue of warrant

(1) A magistrate to whom an application is made under section 74 may issue a warrant, if satisfied that there are reasonable

grounds for believing that entry and inspection of the premises are necessary for the purpose referred to in that section.

- (2) A warrant under subsection (1) authorises the investigator
 - to enter and inspect the premises named in the warrant;
 - (b) to require a person on the premises to answer questions or produce documents or other things concerning the investigation that are in the possession or under the control of the person; and
 - to inspect documents and other things, and take copies of or extracts from documents, produced in compliance with a requirement made under paragraph (b).
- There must be stated in a warrant (3)
 - the purpose for which the warrant is issued;
 - (b) the name of the person to whom the warrant is issued; and
 - a description of the premises that may be entered.
- (4) A magistrate who issues a warrant is to cause a record to be made of particulars of the grounds that the magistrate has relied on to justify the issue of the warrant.

76. **Execution of warrant**

- (1) If asked by an occupier, or a person in charge, of premises, the person executing a warrant at those premises is to produce it for inspection.
- (2) A warrant ceases to have effect
 - at the end of the period of one month after its issue;
 - if it is withdrawn by the magistrate who issued it; or (b)
 - (c) when it is executed,

whichever occurs first.

Division 8 — Conciliation

77. **Conciliation process**

- (1) If an attempt is to be made to settle a complaint by conciliation, the Board is to refer the complaint to the complaints assessment committee.
- (2) The complaints assessment committee is to commence conciliation procedures within 14 days of the complaint being referred to it under subsection (1) and may for that purpose
 - cause conferences of the complainant or person affected by the conduct of the respondent and the respondent, or their representatives, to be arranged and to be presided over by a person appointed in accordance with the regulations:
 - give advice and make recommendations to assist in the (b) reaching of an agreement; and
 - cause the persons concerned, or any of them, either separately or together, to appear before the complaints assessment committee.
- The Board may, with the consent of each of the parties to that (3) agreement, by order give effect to an agreement negotiated under this Division.
- (4) If the Board makes an order under subsection (3)
 - the terms of the agreement reached between the parties referred to in the order are final and binding on those parties; and
 - the order may include any action that might have been (b) taken by the State Administrative Tribunal under section 79(1) or 80(1).
- Evidence of anything lawfully said or done, or any record (5) prepared and produced for the purpose of conciliation, by a person in the course of the conciliation process is not to be used

78. Action if conciliation fails

If—

- (a) the conciliation process fails to result in an agreement between the complainant or other person affected by the conduct of the respondent and the respondent;
- the Board is satisfied that the parties are not cooperating (b) with the conciliation process; or
- the Board is not satisfied with the result of the (c) conciliation process,

the Board is to —

- make a summary order under Division 4;

79. Powers of the State Administrative Tribunal on dealing with a disciplinary matter

- require the person to complete educational or clinical (f) courses, or both, as specified in the order or to practise under supervision as specified in the order for a period specified in the order;
- require the person to seek and implement, within a (g) period specified in the order, advice from a person or persons specified in the order in relation to the management and conduct of the person's practice of medical radiation technology, or the specific part or aspect of the practice specified in the order;
- (h) order the person to pay a penalty not exceeding a fine of \$25 000:
- order that the person's registration be cancelled in relation to all areas of medical radiation technology for which the person is registered and name be removed from the register;
- order that the person be suspended from the practice of medical radiation technology either generally or in relation to any specified area, circumstances or service for a period, not exceeding 2 years, specified in the order.

If, in a proceeding commenced by an allegation under this Act against a person who was a medical radiation technologist when the disciplinary matter allegedly occurred but who is no longer a medical radiation technologist, the State Administrative Tribunal is of the opinion that a disciplinary matter exists in relation to that person, the only powers that the Tribunal may exercise are the powers in subsection (1)(a), (c), (d)(ii) and (iii) and (h).

80. Powers of the State Administrative Tribunal on dealing with an impairment matter

- If, in a proceeding commenced by an allegation under (1) section 69(1)(c), the State Administrative Tribunal is of the opinion that an impairment matter exists in relation to a person, the Tribunal may do one or more of the following —
 - (a) decline to make an order or a requirement under this subsection;
 - order that the person comply with such conditions as the (b) Tribunal may impose on the registration of that person;
 - (c) require the person to seek and undergo medical treatment or counselling specified by the Tribunal;
 - order that the person be suspended from the practice of (d) medical radiation technology either generally or in relation to any specified area, circumstances or service for the period of time, not exceeding 2 years, specified by the State Administrative Tribunal in the order.
- If, during the course of hearing an allegation in respect of an (2) impairment matter, the State Administrative Tribunal determines that the allegation involves a disciplinary matter, the Tribunal may deal with it under section 79(1) or (2) instead of under this section.

Division 10 — Miscellaneous

81. Suspension

- (1) If, under section 55(1)(c), 69(2)(b), 79(1)(j) or 80(1)(d), a person is suspended from the practice of medical radiation technology generally, the person is to be regarded as not being registered during the period of the suspension.
- (2) If, under section 55(1)(c), 79(1)(j) or 80(1)(d), a person is suspended from the practice of medical radiation technology in relation to any specified area, circumstances or service, the person is to be regarded as not being registered during the period of the suspension in relation to the area or circumstances or the performance of the service specified in the order of suspension.
- (3) The Board may, by notice in writing, revoke a suspension, either generally or to a specified extent, and may direct in the notice that the revocation has effect from a date specified in the notice.
- (4) The Board cannot revoke a suspension that was imposed by the State Administrative Tribunal under section 79(1)(j) or 80(1)(d) unless it has applied for, and obtained, the approval of the Tribunal to do so.

82. Costs and recovery

- (1) The Board may, in addition to or instead of exercising a power under section 59(1) or 69(1), order the respondent to pay such costs and expenses of or arising from the investigation and exercise of that power as the Board thinks fit.
- (2) Any costs or expenses ordered to be paid under this section are recoverable by the Board in a court of competent jurisdiction as a debt due to the Board.

Part 6 — Offences

83. Use of title "medical radiation technologist" or a restricted title or pretending to be registered

A person must not —

- use the title "medical radiation technologist" unless the person is a medical radiation technologist;
- use a title as defined in paragraph (a) of the definition of (b) "restricted title" in section 3 unless that person is a medical radiation technologist registered in the area of medical imaging technology;
- use a title as defined in paragraph (b) of the definition of "restricted title" in section 3 unless that person is a medical radiation technologist registered in the area of nuclear medicine technology;
- use a title as defined in paragraph (c) of the definition of (d) "restricted title" in section 3 unless that person is a medical radiation technologist registered in the area of radiation therapy; or
- advertise, or otherwise hold out or imply, that the person is registered or entitled, either alone or with others, to practise medical radiation technology.

Penalty:

- (a) for a first offence, a fine of \$2 500; and a daily penalty of \$100;
- for a second or subsequent offence, a fine of \$5 000; (b) and a daily penalty of \$200.

84. Failure to comply with disciplinary action

A person must not contravene or fail to comply with an order of the Board given to that person under section 55 or 60.

for an individual, a fine of \$5 000; (a)

85. False or misleading information

- (1) A person must not do any of the things set out in subsection (2)
 - in relation to an application;
 - in relation to the compliance, or purported compliance, with any requirement of this Act to give the Board or the registrar advice or information; or
 - in relation to an attempt at conciliation under section 77. Penalty: a fine of \$24 000 or imprisonment for 2 years.
- The things to which subsection (1) applies are (2)
 - making a statement which the person knows is false or misleading in a material particular;
 - (b) making a statement which is false or misleading in a material particular, with reckless disregard as to whether or not the statement is false or misleading in a material particular;
 - providing, or causing to be provided, information that (c) the person knows is false or misleading in a material particular; or
 - (d) providing, or causing to be provided, information that is false or misleading in a material particular, with reckless disregard as to whether the information is false or misleading in a material particular.

86. Offences in relation to investigation

- Where under section 73 a person is required to give any (1) information, answer any question, or produce any document or thing and that person, without reasonable excuse (proof of which lies on the person)
 - fails to give that information or answer that question at or within the time specified in the requirement;

- (b) gives any information or answer that is false in any particular; or
- (c) fails to produce that document or thing at or within the time specified in the requirement,

the person commits an offence.

Penalty:

- It is a defence in any proceeding for an offence under (2) subsection (1)(a) or (c) for the accused to show
 - that, in the case of an alleged offence arising out of a requirement made orally under section 73, the investigator did not, when making the requirement, inform the accused that he or she was required under this Act to give the information or answer the question, as the case may be;
 - that, in the case of an alleged offence arising out of a requirement made by notice in writing under section 73, the notice did not state that he or she was required under this Act to give the information, answer the question, or produce the document or thing, as the case may be;
 - that the time specified in the requirement did not afford the accused sufficient notice to enable him or her to comply with the requirement; or
 - that, in any case, the investigator did not, before making (d) the requirement, have reasonable grounds to believe that compliance with the requirement would materially assist in the investigation being carried out.

87. Obstruction of investigator

A person must not prevent or attempt to prevent an investigator from entering premises or otherwise obstruct or impede an

Penalty:

- for an individual, a fine of \$5 000; (a)
- for a body corporate, a fine of \$10 000. (b)

88. Assistance to execute warrant

A medical radiation technologist, and any person —

- who engages or employs the medical radiation technologist to practise medical radiation technology;
- (b) who is engaged or employed by the medical radiation technologist in the medical radiation technologist's practice; or
- with whom the medical radiation technologist practises medical radiation technology in partnership,

at the premises named in the warrant is to provide all reasonable assistance to an investigator executing the warrant issued under section 75.

Penalty:

- for an individual, a fine of \$5 000;
- for a body corporate, a fine of \$10 000. (b)

89. Surrender of certificate

- (1) Where —
 - (a) a person's registration is cancelled and name removed from the register; or
 - a person is suspended from the practice of medical (b) radiation technology,

the person is, within 14 days after the day on which the person is notified by the Board of the cancellation and removal of name or suspension, to surrender to the Board his or her certificate of registration.

Penalty: a fine of \$1 000.

(2) Where a person's registration is cancelled in an area but not all areas of medical radiation technology, the person is, within 14 days after the day on which the person is notified by the Board of the cancellation, to surrender to the Board his or her certificate of registration.

Penalty: a fine of \$1 000.

- (3) The Board may direct in writing that a person who is suspended from the practice of medical radiation technology under section 55 is not obliged to comply with subsection (1) and, in that case, the subsection does not apply to that person.
- It is a defence to a prosecution for an offence against subsection (1) or (2) if the accused satisfies the court that the failure to surrender the certificate was due to its loss or destruction.

90. Incriminating information, questions, or documents

An individual is not excused from complying with a requirement under section 73 on the ground that the answer to a question or the production of a document or other thing might incriminate the individual or render the individual liable to a penalty, but neither —

- an answer given by the individual that was given to comply with the requirement; nor
- the fact that a document or other thing produced by the individual to comply with the requirement was produced,

is admissible in evidence in any civil or criminal proceedings against the individual other than proceedings for an offence against section 86(1)(b).

91. Legal professional privilege

Nothing in Part 5 or this Part prevents a person from refusing to answer a question, provide information or produce a document or other thing because the answer or information would relate to, or the document or thing contains, information in respect of which the person claims legal professional privilege.

Part 7 — Codes of practice, rules and regulations

92. **Application of Part**

The powers conferred in this Part to —

- issue codes of practice; and
- make rules and regulations, (b)

do not extend to issuing a code of practice or making a rule or regulation relating to the safe operation or use by a medical radiation technologist of a radioactive substance, irradiating apparatus or electronic product as those terms are defined in the Radiation Safety Act 1975 section 4.

93. **Codes of practice**

- (1) The Board may, with the approval of the Minister, issue codes of practice for the practice of medical radiation technology and the conduct of medical radiation technologists.
- The code of practice may adopt the provisions of other (2) publications, whether with or without modification or addition and whether in force at a particular time or from time to time.
- A breach of a code of practice does not of itself constitute a (3) disciplinary matter for the purposes of section 48 but in any proceedings under Part 5 such a breach may be asserted and may be taken into account in determining any question that arises under that Part.
- Except as provided in subsection (3), no civil or criminal (4) liability attaches to a person by reason only that the person has committed a breach of a code of practice.
- (5) The Interpretation Act 1984 sections 41, 42, 43 and 44 apply to the code of practice as if the code of practice were regulations.

94. Rules

- (1) The Board may make rules prescribing all matters required or permitted by this Act to be prescribed by rules or necessary or convenient to be prescribed for carrying out this Act.
- (2) Without limiting subsection (1), rules may be made for all or any of the following purposes
 - (a) prescribing the courses of study and training, including practical experience, to be undertaken, and the examinations to be passed, by persons desiring to be registered under this Act, and determining the qualifications to be held by persons wanting to study medical radiation technology;
 - (b) regulating the holding of examinations and the appointment of examiners and for the issue of diplomas or certificates to persons passing the examinations;
 - (c) regulating the practice of medical radiation technology by medical radiation technologists and the manner of carrying on that practice;
 - (d) prescribing what diplomas, degrees or certificates of schools of medical radiation technology or other evidence of qualification will be recognised and accepted by the Board as a substitute for the examinations of the Board, and whether immediately or after further training;
 - (e) regulating the manner in which medical radiation technologists may advertise or display or publicise their practice of medical radiation technology.
- (3) A rule made under subsection (1) has no effect unless and until it is confirmed by the Governor.
- (4) Nothing in subsection (3) affects the operation of the *Interpretation Act 1984* Part VI.

(5) The rules may provide that contravention of a rule is an offence, and provide, for an offence against the rules, a penalty not exceeding a fine of \$5 000.

95. Regulations

- The Governor may make regulations (1)
 - prescribing all matters that are required or permitted by the Act to be prescribed by regulation; and
 - (b) with respect to any matter on which the Board may make rules.
- (2) Without limiting subsection (1), regulations may be made for all or any of the following purposes
 - regulating the meetings and proceedings of, and the conduct of business by, the Board or a committee;
 - (b) making provisions relating to registration, including applications for and the amendment or renewal of registration;
 - (c) maintaining the accuracy of the register;
 - (d) regulating the issue, display and use of certificates of registration;
 - regulating the manner of making to the complaints (e) assessment committee any complaint against or concerning a person who is, or was, registered and who may make such a complaint;
 - (f) regulating the conduct of investigations under Part 5;
 - regulating the conduct of conciliation conferences under (g) section 77 and the appointment of persons to preside over those conferences;
 - prescribing the fees to be paid for the purposes of this (h) Act and the persons liable for payment;
 - prescribing returns and notices that are to be given to the Board, and the manner in which they are to be given;

- (j) providing that information supplied to the Board may be required to be verified by statutory declaration.
- (3) Where a regulation is inconsistent with a rule the regulation prevails to the extent of the inconsistency.
- (4) The regulations may provide that contravention of a regulation is an offence, and provide, for an offence against the regulations, a penalty not exceeding a fine of \$5 000.

96. Forms

Forms that are convenient for the purposes of this Act may be —

- (a) prescribed by the regulations or rules; or
- (b) approved.

97. **Protection**

- (1) An action in tort does not lie against a person for anything that the person has done, in good faith, in the performance or purported performance of a function under this Act.
- (2) The Crown is also relieved of any liability that it might otherwise have had for another person having done anything as described in subsection (1).
- The protection given by this section applies even though the (3) thing done as described in subsection (1) may have been capable of being done whether or not this Act had been enacted.
- In this section, a reference to the doing of anything includes a (4) reference to an omission to do anything.
- (5) A person who, in relation to any investigation under Part 5
 - performs any function under that Part; or
 - is otherwise concerned in proceedings under that Part,

has, in respect of any such function or concern, the same protection and immunity as a member or officer of the Supreme Court, or a witness or party before the Supreme Court, would have in respect of a function or concern of a like nature related to the jurisdiction of the Supreme Court.

98. Notice of decision to be given

- (1) Subsection (2) applies to the following decisions
 - any decision refusing an application to the Board for (a) registration;
 - any decision to impose, or vary, a condition under (b) section 27, 28, 29, 30 or 35(4), otherwise than by consent:
 - any decision under section 29(4); or

- (d) any decision to remove a name from the register under section 41.
- (2) If the Board makes a decision to which this subsection applies, it is to record the grounds on which the decision was based, and its reasons, and is as soon as is practicable, but in any case not later than 30 days after making the decision, to give written notice of the decision, together with those grounds and reasons, to the person to whom the decision relates.

99. Review

A person who is aggrieved by —

- (a) an order under section 55 or 60; or
- (b) a decision referred to in section 98(1),

may apply to the State Administrative Tribunal for a review of the order or decision.

100. Publication of proceedings etc.

- (1) Subsection (2) applies to the following
 - (a) the Board, any member of the Board, the registrar or any officer or delegate of the Board or registrar;
 - (b) the Radiological Council;
 - (c) any committee or any member of a committee or person referred to in section 15(5);

 - any person referred to in subsection (1)(d) or (e); (a)
 - (b) the Radiological Council;
 - (c) any body that has granted the person a qualification that is entered in the register;
 - any relevant professional association or trade union of (d) which the person is a member;
 - any person who has engaged or employed the person to practise medical radiation technology or any person with whom the person practises medical radiation technology in partnership; and
 - any other person who, in the opinion of the Board, (f) should be made aware of the finding, reason or decision,

and may publish notice of the finding, reason or decision in the Gazette or in such other manner as the Board thinks fit.

101. Legal proceedings

- Any proceedings for an offence against this Act may be taken in the name of the Board by the registrar or any other person authorised in that behalf by the Board.
- (2) All proceedings for offences against this Act are to be heard by a court of summary jurisdiction constituted by a magistrate.

- If a body corporate and an officer are charged as permitted by subsection (1) and the body corporate is convicted of the offence, the officer is to be taken to have also committed the offence, subject to subsection (5).
- (3) If a body corporate commits an offence under this Act, then, although the body corporate is not charged with the offence, every person who was an officer of the body corporate at the time the offence was committed may be charged with the offence.

Division 1 — General provisions

1. Term of office

- (1) Subject to clause 4, a member of the Board holds office for such term, not exceeding 3 years, as is specified in the member's instrument of appointment.
- (2) Subject to subclause (3), a member of the Board is not to hold office for more than 9 years, consecutively or otherwise.
- If in the opinion of the Minister there are special reasons for doing so, (3) a person may be appointed so that he or she holds office for more than 9 years, consecutively or otherwise.

2. Functions of deputy presiding member

- The deputy presiding member is to perform the functions of the (1) presiding member when the presiding member is unable to do so by reason of illness, absence or other cause, or when the office of presiding member is vacant.
- No act or omission of the deputy presiding member acting as (2) presiding member is to be questioned on the ground that the occasion for his or her so acting had not arisen or had ceased.

3. Deputy members

- (1) The Minister may appoint an eligible person to be a deputy of a member and may terminate such an appointment at any time.
- The provisions of section 5 that apply to and in relation to the (2) appointment of a member apply, with any necessary modification, to and in relation to the appointment of the deputy of that member.
- (3) A deputy of a member may perform the functions of the member when the member is unable to do so by reason of illness, absence or other cause.

- (4) Despite anything in this Act, a deputy of a member may continue to act as a member, after the occasion for so acting has ceased, for the purpose of completing any function.
- (5) A deputy of a member, while acting as a member, has all the functions of and all the protection given to a member.
- (6) No act or omission of a person acting in place of another under this clause is to be questioned on the ground that the occasion for so acting had not arisen or had ceased.

4. Vacation of office by member

- (1) A member of the Board may resign from office by notice in writing given to the Minister.
- (2) A member who resigns under subclause (1) is to give a copy of the notice of resignation to the registrar.
- (3) A member of the Board may be removed from office by the Minister
 - (a) for mental or physical disability, incompetence, neglect of duty or misconduct that impairs the performance of the member's duties:
 - (b) if the member is an insolvent under administration, as that term is defined in the Corporations Act section 9;
 - (c) if the member is absent without leave of the Board from 3 consecutive meetings of the Board of which the member has had notice; or
 - (d) for any other act or omission that in the opinion of the Minister may cause prejudice or injury to the Board.
- (4) A member of the Board must be removed from office by the Minister if the member ceases to hold a position or qualification by virtue of which the member was appointed or if, in the case of a member who is a medical radiation technologist, the registration of the member under this Act is suspended.

5. General procedure concerning meetings

(1) The presiding member is to preside at all meetings of the Board at which he or she is present.

- (2) If both the presiding member and deputy presiding member are absent from a meeting the members present are to appoint one of their number to preside.
- (3) A quorum for a meeting of the Board is 5 members.
- (4) The procedure for convening meetings of the Board and the conduct of business at those meetings is, subject to this Act, to be as determined by the Board.

6. Voting

- (1) A decision of the majority of members at a meeting of the Board at which a quorum is present is the decision of the Board.
- (2) If the votes of members present at a meeting and voting are equally divided the member presiding at the meeting is to have a casting vote in addition to a deliberative vote.

7. Holding meetings remotely

The presence of a person at a meeting of the Board need not be by attendance in person but may be by that person and each other person at the meeting being simultaneously in contact by telephone, or other means of instantaneous communication.

8. Resolution without meeting

A resolution in writing signed by each member of the Board or assented to by each member by letter, facsimile transmission, electronic mail or other written means has effect as if it had been passed at a meeting of the Board.

9. Minutes

The Board is to ensure that an accurate record is kept and preserved of the proceedings at each meeting of the Board and of each resolution passed by the Board.

10. Meaning of "member"

In this Division —

member means a member of the Board or a member of a committee, as the case may be.

11. **Disclosure of interests**

(1) A member who has a material personal interest in a matter being considered or about to be considered by the Board or a committee must, as soon as possible after the relevant facts have come to the member's knowledge, disclose the nature of the interest at a meeting of the Board or the committee.

Penalty: a fine of \$10 000.

(2) A disclosure under subclause (1) is to be recorded in the minutes of the meeting.

12. **Exclusion of interested member**

- **(1)** A member who has a material personal interest in a matter that is being considered by the Board or a committee
 - must not vote, whether at a meeting or otherwise, on the matter; and
 - must not be present while the matter is being considered at a (b) meeting.
- In subclause (1)(a) or (b) a reference to a matter also refers to a (2) proposed resolution under clause 13 in respect of the matter, whether relating to that member or a different member.

13. Board or committee may resolve that clause 12 inapplicable

Clause 12 does not apply if the Board or a committee has at any time passed a resolution that —

- specifies the member, the interest, and the matter; and (a)
- states that the members voting for the resolution are satisfied (b) that the interest should not disqualify the member from considering or voting on the matter.

14. Quorum where clause 12 applies

(1) Despite clause 5(3), when the Board is dealing with a matter in relation to which a member of the Board is disqualified under clause 12, 4 members who are entitled to vote on any motion that may be moved in relation to the matter constitute a quorum.

(2) The Minister may deal with a matter to the extent that the Board cannot deal with it because of subclause (1).

15. Minister may declare clauses 12 or 14 inapplicable

- **(1)** The Minister may by writing declare that clause 12 or 14 does not apply in relation to a specified matter, either generally or for the purpose of dealing with particular proposed resolutions.
- (2) The Minister is to, within 14 sitting days after a declaration under subclause (1) is made, cause a copy of the declaration to be laid before each House of Parliament.

In this Schedule —
