## **Workers' Compensation and Injury Management (Acts of Terrorism) (Final Day) Regulations 2002**

### **1. Citation**

These regulations may be cited as the *Workers' Compensation and Injury Management (Acts of Terrorism) (Final Day) Regulations 2002*<sup>1</sup>.

### **2. Final day prescribed (section-3)**

For the purposes of paragraph (b) of the definition of "*final day*"<sup>2</sup> in section 3 of the Act, the final day is 31 December 2012.
