1. Citation

These rules may be cited as the *Limited Partnerships Rules* 1909¹.

1A. Interpretation

In these rules, *the Act* means the *Limited Partnerships Act 1909*. [*Rule 1A inserted in Gazette 30 Dec 1983 p. 5023.*]

2. The Registrar of Companies

Whenever any act is by the Act directed to be done to or by the Registrar ² such act shall be done to or by the Registrar of Companies or in his absence to or by such person as the Attorney General may for the time being authorise.

3. Fees

The fees to be paid to the Registrar under set out in the Table are payable in respect of the Act shall be as follows:
