Marine Navigational Aids Regulations 1985

1. Citation

These regulations may be cited as the *Marine Navigational Aids Regulations 1985*¹.

2. Commencement

These regulations shall come into operation on the coming into operation of the *Marine Navigational Aids Amendment Act 1978*¹.

3. Fees payable in respect of fishing boats

- (1) The master and the owner of a fishing boat other than a fishing boat
 - (a) which does not exceed 5.5 metres in length exclusive of bowsprit;
 - (b) engaged solely in fishing in estuaries or inland waters; or
 - (c) for which conservancy dues are prescribed as payable under the *Ports and Harbours Regulations 1966²* made under the *Shipping and Pilotage Act 1967*,

are jointly and severally liable to pay to the Department the fee set out in the Schedule 1 that is appropriate to that fishing boat.

(2) The fee referred to in subregulation (1) is payable —
