# W.A. Marine (Load Lines) Regulations 1983

#### 1. Citation

These regulations may be cited as the W.A. Marine (Load Lines) Regulations 1983 <sup>1</sup>.

#### 2. Commencement

These regulations shall come into operation on 1 July 1983.

#### 3. **Interpretation** Terms used

In these regulations, unless the contrary intention appears (1) Authority means the chief executive officer:

*Code* means the Uniform Shipping Laws Code incorporating the amendments adopted by the Australian Transport Council, referred to in section 115 of the Act, as in existence on 1 October <del>2007;</del>2009.

NSCV means(2) In the National Standard for Commercial Vessels described in the Code.

Note: The definition of *Code* refers to the Code as amended by Amendment Lists 5 and 6 adopted by the Australian Transport Council on 1 October 2007 and available at http:/www.nmsc.gov.au/uslcode 2.html . That version of the Code contains provisions that affect of the operation of Code incorporated in these regulations that refer to, a term has the same meaning as it, and should be referred to when interpreting those regulations has in the Code.

#### 4. **Application of Section 7 of Code**

- Subject to subregulation (2), the provisions of Section 7 of the (1) Code are incorporated in these regulations and shall extend and apply to and in respect of all vessels and voyages to which the Act applies.
- (2) The incorporation and application of Section 7 of the Code by subregulation (1) is subject to the following modifications
  - for the definition of *Survey authority* in clause 3.9, there is substituted the following definition —

survey authority means an authority appointed by the Governor under Section 31 of the Act.

- clause 73.6 shall be deleted; (b)
- clauses 74.1 and 74.2 shall be deleted; (c)
- (d) clauses 74.4 and 74.5 shall be deleted; and
- clauses 74.7 and 74.8 shall be deleted.

#### **[5.** Construction of Code

In the construction of the Code as incorporated in these regulations, words and expressions defined in the NSCV, Part B, Clause 1.8 shall, unless otherwise provided by the Act or these regulations, have the meanings assigned in that clause.

#### 6. **Fees**

- A fee of \$26 for each metre of the load line length shall be (1) payable for the initial load line survey of a vessel and the issue of a certificate.
- For the renewal of a load line survey (every 5 years), a fee of (2) \$55 shall be payable if the renewal survey is carried out in conjunction with the annual survey of the vessel and if the renewal survey is carried out at any other time the fee shall be \$55 plus \$20 for every half hour during which the surveyor is engaged on the survey.
- (3) The fee for an annual load line survey carried out other than in conjunction with the annual survey of a vessel shall be \$20 for each half hour during which the surveyor is engaged on the survey.
