# Water Agencies (Infringements) **Regulations 1994**

#### 1. Citation

These regulations may be cited as the *Water Agencies* (Infringements) Regulations 1994<sup>1</sup>.

#### 2. Commencement

These regulations come into operation on 1 November 1994.

#### 3. **Prescribed offences**

The offence under by-law 4 of the Water Agencies (Water Use) *By-laws* 20072010 by-law 4 is prescribed as an offence that may be dealt with under section 103 of the Act.

#### 4. **Modified penalty**

The amount prescribed to apply in respect of each of the offences referred to in regulation 3, if it is dealt with under section 103 of the Act, is \$100.


