# Bills of Sale (Fees) Regulations 1983

#### 1. Citation

These regulations may be cited as the *Bills of Sale (Fees) Regulations 1983* <sup>1</sup>.

#### 2. Commencement

These regulations shall come into operation on 1 March 1984.

#### 3. Fees
