Bills of Sale (Fees) Regulations 1983

1. Citation

These regulations may be cited as the *Bills of Sale (Fees) Regulations 1983*¹.

2. Commencement

These regulations shall come into operation on 1 March 1984.

3. Fees

The following fees are prescribed for the purposes of the *Bills of Sale Act 1899* —
