1. Citation

These regulations may be cited as the *Petroleum and Geothermal Energy Resources (Registration Fees) Regulations 1990* ¹.

2. Commencement

These regulations shall come into operation on the commencement of the *Petroleum* (*Registration Fees*) *Amendment Act 1990* ¹.

3. Prescribed amounts

- (1) For the purposes of section 4(2) of the Act, the prescribed amount is an amount of \$938958.00.
- (2) For the purposes of section 4(3) of the Act, the prescribed amount is an amount of \$938958.00.
- (3) For the purposes of section 4(4) of the Act, the prescribed amount is an amount of \$4 \frac{690788}{.00}.
- (4) For the purposes of section 4(6) of the Act, the prescribed amount is an amount of \$938958.00.
