### **Dental Prosthetists Regulations 1986**

#### 1. Citation

These regulations may be cited as the *Dental Prosthetists Regulations* 1986 <sup>1</sup>.

#### 2. Commencement

These regulations shall come into operation on the day on which the *Dental Prosthetists Act 1985* comes into operation <sup>1</sup>.

#### 3. Form of summons issued by Committee

A summons issued by the Committee under section 12(4) of the Act shall be in the form of Form 1 in Schedule 2.

#### 4. Form of application for licence

An application under section 17 of the Act shall be in the form of Form 2 in Schedule 2.

#### 5. Form of licence

A licence issued under section 18 of the Act shall be in the form of Form 3 in Schedule 2.

#### 6. Record of applications

In addition to showing the particulars prescribed by section 23(2)(a) to (d) of the Act, the record referred to in

section 23(1) of the Act shall show, in respect of each person to whom a licence is or has been issued —

- the date that the licence was issued to that person; and
- (b) where that person has died, the date of that person's death.

#### 7. Certificate for the purpose of legal proceedings

A certificate issued under section 27(6) of the Act shall be in the form of Form 4 in Schedule 2.

#### 8. **Fees**

The fee payable in respect of a matter referred to in column 2 of Schedule 1 is that which is respectively set out in column 3 of that Schedule.

#### 9. **Prescribed qualifications**

For the purposes of section 18(1)(b) of the Act —

- the Technical Education Division of the Ministry of Education <sup>2</sup> in Western Australia is a prescribed educational authority; and
- a Certificate in Complete Denture Prosthetics from the (b) educational authority prescribed in paragraph (a) is a prescribed qualification.
