Salaries and Allowances Regulations 1975

1. Citation

These regulations may be cited as the *Salaries and Allowances Regulations 1975* ¹.

2. Interpretation

In these regulations, unless the context requires otherwise, — *the Act* means the *Salaries and Allowances Act* 1975.

3. Prescribed offices

The offices created or established under the written laws specified in column 1 of the Schedule and specified in column 2 of that Schedule opposite and corresponding to those written laws are prescribed offices for the purposes of section 6 of the Act.
