Lotteries Commission (Designated Authorities) Regulations 1998

Made by the deputy of the Governor in Executive Council under section 3(4)

1. Citation

These regulations may be cited as the *Lotteries Commission* (Designated Authorities) Regulations 1998.

2. Commencement

These regulations come into operation on the day on which the *Lotteries Commission Amendment Act 1998* comes into operation.

3. Designated authorities

For the purposes of section 6 of the Act, each of the following is prescribed as "designated authority" —

thein relation to the State of New South Wales, New South Wales Lotteries Corporation established by the New South Wales Lotteries Corporatisation Act 1996, as from time to time amended, of the State of New South Wales Pty Limited ACN 142 890 195;

the Golden Casket Lottery Corporation Limited CAN 078 785 449 continued by the *Lotteries Act 1997*, as from time to time amended, of the State of Queensland;
