Agriculture and Related Resources Protection (Spraying Restrictions) Regulations 1979

1. Short title

These regulations may be cited as the *Agriculture and Related Resources Protection (Spraying Restrictions) Regulations 1979*¹.

2. Interpretation

In these regulations, unless the contrary intention appears —

acid means a chemical, whether in a salt, amine or other form, listed in the Schedule;

Director means the Director General of Agriculture or an officer of the Department of Agriculture authorised by him in writing;

prescribed area means an area described in regulation 3.

3. Prescribed areas

The following areas are prescribed areas for the purposes of these regulations —

- (a) any area within 5 kilometres of a place where tomatoes or grapevines are being grown for commercial purposes;
- (b) any area being more than 5 kilometres but not more than 10 kilometres from a place where tomatoes or grapevines are being grown for commercial purposes;

(c)	the area within an imaginary circle having a radius of
	19 kilometres with the Geraldton Post Office as its
	centre;

- [(d) deleted]
 - (e) the area within an imaginary circle having a radius of 50 kilometres with the Geraldton Post Office as its centre but outside an imaginary circle having a radius of 19 kilometres with the Geraldton Post Office as its centre;
 - (f) an area within 10 kilometres of a place where irrigated agricultural or horticultural crops are being grown for commercial purposes which is situated within 50 kilometres of the Kununurra Post Office;
 - (g) an area more than 10 kilometres but not more than 50 kilometres from a place where irrigated agricultural or horticultural crops are being grown for commercial purposes which is situated within 50 kilometres of the Kununurra Post Office;
 - (h) all the land bounded by lines starting from the junction of Ida Street and Anzac Terrace in the town of Bassendean extending east to the southeast corner of Swan location 3218; then north to the southeast corner of Swan location 1339; then west to the northwest corner of Swan location 277; then south to the starting point.

4. Spraying of acids

- (1) A person shall not, within the prescribed areas described in regulation 3(a), (c), (f) or (h), spray
 - (a) an ester of an acid; or
 - (b) unless he has the prior written approval of the Director, a chemical containing an acid.

Penalty: a fine of \$2 000.

- (2) A person shall not, within the prescribed areas described in regulation 3(b), (e) or (g), spray an ester of an acid unless the ester is a low volatile kind approved by the Director and notified in the *Government Gazette*.
- (3) A person who contravenes subregulation (1) or (2) commits an offence and is liable to a penalty of \$500.

Penalty: a fine of \$2 000.

5. Storage of esters of acids


- (1) A person shall not, within the prescribed areas described in regulation 3(c), (e), (f) or (g), store an ester of an acid unless
 - (a) the ester is a low volatile kind approved by the Director and notified in the *Government Gazette*; or
 - (b) except in the case of the prescribed area described in regulation 3(c), he has obtained the prior written approval of the Director.

Penalty: a fine of \$2 000.

- (2) An <u>inspector authorised person</u> who finds an <u>ester of an</u> acid stored in contravention of subregulation (1) <u>shall forthwith</u> -<u>must</u>
 - (a) seize and remove the <u>acidester</u> from the prescribed area concerned; or
 - (b) direct the owner or occupier of the land on which the acidester is stored, or hisan agent of that person, to remove the acidester from the prescribed area concerned forthwith, within a time specified in the direction.

<u>and a(3A)</u> <u>A</u> person who is given a direction under <u>paragraph (subregulation (2)(b) shallmust</u> comply with <u>itthe</u> <u>direction</u>.

7. Applications to Director

An application for an approval under regulation 4(1)(b) or 5(1)(b) shall be in writing and shall contain —

- (a) in the case of an application under regulation 4(1)(b), particulars of
 - (i) the approximate area to be sprayed;
 - (ii) the location of the area to be sprayed;
 - (iii) the acid and the form of the acid to be used;
 - (iv) the method of spraying and the equipment to be used; and
 - (v) the proposed date of spraying;
 - and
- (b) in the case of an application under regulation 5(1)(b), particulars of
 - (i) the location of the storage area; and
 - (ii) the kind of ester of acid to be stored.
