# W.A. Marine (Load Lines) Regulations 1983

### 1. Citation

These regulations may be cited as the W.A. Marine (Load Lines) Regulations 1983<sup>1</sup>.

### 2. Commencement

These regulations shall come into operation on 1 July 1983.

#### 3. Terms used

(1) In these regulations —

*Code* means the Uniform Shipping Laws Code, referred to in section 115 of the Act, as in existence on 1 October 2009.

(2) In the provisions of the Code incorporated in these regulations, a term has the same meaning as it has in the Code.

## 4. Application of Section 7 of Code

(1) Subject to subregulation (2), the provisions of Section 7 of the Code are incorporated in these regulations and shall extend and apply to and in respect of all vessels and voyages to which the Act applies.
