1. Citation

These regulations may be cited as the *Petroleum and* Geothermal Energy Resources (Registration Fees) Regulations 1990¹.

2. Commencement

These regulations shall come into operation on the commencement of the Petroleum (Registration Fees) Amendment Act 1990 ¹.

3. Prescribed amounts

- (2) For the purposes of section 4(3) of the Act, the prescribed amount is an amount of \$958987.00.
- (3) For the purposes of section 4(4) of the Act, the prescribed amount is an amount of \$4 788932.00.

- (4) For the purposes of section 4(6) of the Act, the prescribed amount is an amount of \$958987.00.
- (5) For the purposes of section 4(7) of the Act, the prescribed amount is an amount of \$4 788932.00.
