Local Government (Prohibition on Dealings in Land) Regulations 1973

1. Citation

These regulations may be cited as the *Local Government* (*Prohibition on Dealings in Land*) *Regulations 1973* ¹.

2. Prescribed form for s. 412A

The prescribed form for the purposes of section 412A of the *Local Government (Miscellaneous Provisions) Act 1960*, shall be in the form set out in the Schedule to these regulations.


