## **Bills of Sale (Fees) Regulations 1983**

### **1. Citation**

These regulations may be cited as the *Bills of Sale (Fees) Regulations 1983*<sup>1</sup>.

### **2. Commencement**

These regulations shall come into operation on 1 March 1984.

### **3. Fees**

The following fees are prescribed for the purposes of the *Bills of Sale Act 1899* —

(a) Registration or renewal of registration of a bill of sale .....	30.80
(b) On entering satisfaction (including fee for filing the affidavit of execution) .....	13.20
(c) Lodging of an application under section 13A of the Act (including supporting affidavit) .....	16.50
(d) Inspection of the documents kept by the Registrar as to an individual registration .....	29.80
(e) Copy (certified or uncertified) or an extract of an individual registration or an affidavit —	
first page .....	26.40
each subsequent page .....	4.40
