1. Citation

These regulations may be cited as the *Petroleum and Geothermal Energy Resources (Registration Fees) Regulations 1990*¹.

2. Commencement

These regulations shall come into operation on the commencement of the *Petroleum (Registration Fees)* Amendment Act 1990¹.

3. Prescribed amounts

- (1) For the purposes of section 4(2) of the Act, the prescribed amount is an amount of 9871 125.00.
- (2) For the purposes of section 4(3) of the Act, the prescribed amount is an amount of $\frac{9871 125}{0.00}$.
- (3) For the purposes of section 4(4) of the Act, the prescribed amount is an amount of 49325622.00.
- (4) For the purposes of section 4(6) of the Act, the prescribed amount is an amount of $\frac{9871 \ 125}{00}$.
