Motor Vehicle Dealers (Prescribed Vehicles) Regulations 1974

1. Citation

These regulations may be cited as the *Motor Vehicle Dealers (Prescribed Vehicles) Regulations 1974*¹.

2. ~~Interpretation~~ Terms used

In these regulations, ~~unless the context otherwise requires~~ — caravan means a ~~caravan (trailer type) as described, including a camper trailer, fitted for human habitation~~ in the ~~First Schedule~~ course of a journey;

goods vehicle means a motor vehicle designed to be used primarily to carry goods or materials used in any trade, business or industry;

motor vehicle has the same meaning as in the *Road Traffic Act 1974*;

~~motor wagon~~ trailer means a ~~motor wagon as described in the First Schedule~~ vehicle designed to the Road Traffic Act 1974;

~~the Act~~ means the *Motor Vehicle Dealers Act 1973* be drawn by a motor vehicle.

3. Prescribed vehicles under section 5(3)(e)

Vehicles of a type or class set out in the table to this regulation are prescribed vehicles for the purposes of section 5(3)(e) of the Act.

2. Four wheel drive vehicles

4. Passenger vans used wholly or principally for the conveyance of persons and sold with a seating capacity not exceeding 8 persons.
