1. Citation

These regulations may be cited as the *Motor Vehicle Dealers* (*Prescribed Vehicles*) Regulations 1974¹.

2. Interpretation Terms used

In these regulations, unless the context otherwise requires _____

caravan means a caravan (trailer type) as described, <u>including a</u> <u>camper trailer</u>, <u>fitted for human habitation</u> in the First <u>Schedule</u>course of a journey;

goods vehicle means a motor vehicle designed to be used primarily to carry goods or materials used in any trade, business or industry;

motor vehicle has the same meaning as in the *Road Traffic Act 1974*;

motor wagont<u>railer</u> means a motor wagon as described in the First Schedule<u>vehicle designed</u> to the *Road Traffic Act 1974*;

the Act means the *Motor Vehicle Dealers Act 1973* be drawn by <u>a motor vehicle</u>.

Vehicles of a type or class set out in the table to this regulation are prescribed vehicles for the purposes of section 5(3)(e) of the Act.

- 3. <u>Motor wagons Goods vehicles</u>
- 4. Passenger vans used wholly or principally for the conveyance of persons and sold with a seating capacity not exceeding 8 persons.
