## **Emergency Services Levy Act 2002**

An Act to impose the emergency services levy determined under the *Fire and Emergency Services Authority of Western Australia* Act 1998.

[Long title amended: No. 22 of 2012 s. 120.]

#### 1. Short title

This Act may be cited as the *Emergency Services Levy Act 2002*.

### 2. Commencement

This Act comes into operation on the day on which section 15 of the *Fire and Emergency Services Legislation (Emergency Services Levy) Amendment Act 2002* comes into operation.

#### 3. Emergency services levy imposed

The emergency services levy determined under Part 6A of the *Fire and Emergency Services <u>Authority of Western Australia</u> Act 1998* is imposed.
