Rates and Charges (Rebates and Deferments) Regulations 1992

1. Citation

These regulations may be cited as the *Rates and Charges* (*Rebates and Deferments*) *Regulations* 1992¹.

2. Urban drainage charges

A charge made under the *Land Drainage Act 1925* for the provision of urban drainage is prescribed for the purposes of paragraph (d) of the definition of *prescribed charge* in section 3(1) of the Act.

3. Maximum limit for rebate

The limit on the amount of rebate that an eligible senior is to be allowed <u>onfor</u> a <u>type of</u> prescribed charge referred to in section 40(9)(a) and (c) of the Act is the amount set in the following Table for <u>that</u> <u>a</u> charge <u>of that type</u> for the rating year during which the service to which the charge relates was provided.
