Police (Fees) Regulations 1981

1. Citation

These regulations may be cited as the *Police* (*Fees*) *Regulations* 1981 ¹.

2. Fees

- (1) A fee specified in Schedule 1 is the fee payable for the purpose set out opposite the fee in that Schedule.
- (2) The Commissioner of Police may reduce, waive or refund, in whole or in part, any moneys due under this regulation.

3. Terms used

In these regulations —

accident has the same meaning as in Part V of the Road Traffic Act 1974;

department means the department of the Public Service principally assisting the Minister in the administration of the Act:

road traffic conviction record, in respect of a person, means the record held in the department of the person's convictions against the *Road Traffic Act 1974*;

traffic infringement notice record, in respect of a person, means the record held in the department of infringement notices served on the person under the Road Traffic Act 1974 section 102.
