Rates and Charges (Rebates and Deferments) Regulations 1992

1. Citation

These regulations may be cited as the *Rates and Charges (Rebates and Deferments) Regulations 1992*¹.

2. ~~Urban drainage~~Annual water supply charges of the Bunbury and Busselton Water Corporations

A charge ~~made~~ under the ~~*Land Drainage Act 1925*~~*Water Services (Water Corporations Charges) Regulations 2013 Part 3 or 4* for the provision of ~~urban drainage~~a water supply service, other than a quality/quantity charge, is prescribed for the purposes of paragraph (d) of the definition of *prescribed charge* in section 3(1) of the Act.

3. Maximum limit for rebate

The limit on the amount of rebate that an eligible senior is to be allowed for a type of prescribed charge referred to in section 40(9)(a) and (c) of the Act is the amount set in the following Table for a charge of that type for the rating year during which the service to which the charge relates was provided.
