## Petroleum (Submerged Lands) Registration Fees Regulations 1990

#### 1. Citation

These regulations may be cited as the *Petroleum* (Submerged Lands) Registration Fees Regulations 1990 <sup>1</sup>.

#### 2. Commencement

These regulations shall come into operation on the commencement of the *Petroleum (Submerged Lands) Registration Fees Amendment Act* 1990 <sup>1</sup>.

## 3. Amounts prescribed (Act s. 4)

- (1) For the purposes of section 4(2) of the Act, the prescribed amount is an amount of \$\frac{1}{125}4\) 779.00.
- (2) For the purposes of section 4(3) of the Act, the prescribed amount is an amount of \$\frac{1}{1254}\) 779.00.
- (3) For the purposes of section 4(4) of the Act, the prescribed amount is an amount of \$5 6227 482.00.
- (4) For the purposes for section 4(6) of the Act, the prescribed amount is an amount of  $\frac{1125}{4779}$ .00

(5) For the purposes of section 4(7) of the Act, the prescribed amount is an amount of  $$\frac{5.6227}{482.00}$ .
