## Coal Industry Superannuation (Designated Trustee) Regulations (No. 2) 2014

### 1. Citation

These regulations are the *Coal Industry Superannuation (Designated Trustee) Regulations (No. 2) 2014*.

### 2. Commencement

These regulations come into operation as follows —

- (a) regulations 1 and 2 — on the day on which these regulations are published in the *Gazette*;
- (b) the rest of the regulations — on the day on which the *Coal Industry Superannuation Amendment Act 2013* Part 3 comes into operation.

- (b) now registered with the Australian Prudential Regulatory Authority with the name “AUSCOAL Superannuation Fund” and the registration number R1056563.
