# Rates and Charges (Rebates and Deferments) Regulations 1992 

## 1. Citation

These regulations may be cited as the Rates and Charges (Rebates and Deferments) Regulations $1992{ }^{1}$.
2. Annual water supply charges of Bunbury and Busselton Water Corporations

A charge under the Water Services (Water Corporations Charges) Regulations 2013 Part 3 or 4 for the provision of a water supply service, other than a quality/quantity charge, is prescribed for the purposes of paragraph (d) of the definition of prescribed charge in section 3(1) of the Act.

## 3. Maximum limit for rebate

The limit on the amount of rebate that an eligible senior is to be allowed for a type of prescribed charge referred to in section $40(9)$ (a) and (c) of the Act is the amount set in the following Table for a charge of that type for the rating year
