## Health (Offensive Trades Fees) Regulations 1976

#### 1. Citation

These regulations are the *Health* (*Offensive Trades Fees*) *Regulations 1976*<sup>1</sup>.

#### 2. Application

These regulations have effect in every local government <sup>2</sup> district within the State as if they were local laws made under the Act.

#### **3. Prescribed fees**

The fees set out in the Table to this regulation are payable on the registration of —

- (a) the offensive trades specified in Schedule 2 of the Act; or
- (b) any process or class of trade declared to be an offensive trade under section 186 of the Act.
